A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 461-1, Hawaii Revised Statutes, is 2 amended by adding a new definition to be appropriately inserted 3 and to read as follows: ""Telepharmacy" means remote dispensing of medications as 4 5 directed by a licensed pharmacist via a computer or telephone 6 link to a secure machine where the accuracy of the prescription is verified by a doctor, nurse, pharmacist assistant, or 7 8 pharmacy technician." 9 SECTION 2. Section 461-9, Hawaii Revised Statutes, is 10 amended to read as follows: 11 "§461-9 Pharmacist in charge; pharmacy personnel. (a) A 12 registered pharmacist shall be in personal and immediate charge 13 of the pharmacy and personnel employed in the pharmacy. 14 Temporary absences of the registered pharmacist shall be 15 unlawful except for periods of time and under circumstances as 16 authorized under the rules of the board. During any absence of 17 the registered pharmacist, prescriptions may not be filled,
