# A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. According to the department of land and natural
- 2 resources alien species have caused substantial damage to
- 3 Hawaii's environment, economy, natural resources, and native
- 4 ecosystem.
- 5 Hawaii has the highest rate of extinction of its native
- 6 species within the United States and has one of the highest
- 7 rates of extinction to its native species within the entire
- 8 world.
- 9 The purpose of this Act is to appropriate funds to be
- 10 granted to organizations whose purpose is the eradication of
- 11 invasive species, the prevention of the spreading of invasive
- 12 species, and the protection of native species.
- 13 SECTION 2. Section 150A-4.5, Hawaii Revised Statutes, is
- 14 amended by amending subsection (b) to read as follows:
- 15 "(b) The moneys in the pest inspection, quarantine, and
- 16 eradication fund shall be expended by the department for [the]:

16	SECTION 4. There is appropriated out of the pest	
17	inspection, quarantine, and eradication fund the sum of	
18	\$	or so much thereof as may be necessary for fiscal
19	year 2008	-2009 for the issuance of grants in accordance with
20	section 150A-4.5(b)(3), Hawaii Revised Statutes.	
21	The s	sum appropriated shall be expended by the department of
22	agriculture for the purposes of this Act.
