A BILL FOR AN ACT

RELATING TO EPILEPSY DISEASE ASSISTANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The Hawaii Revised Statutes is amended by

adding a new chapter to be appropriately designated and to read

s follows:

"CHAPTER

EPILEPSY DISEASE ASSISTANCE

S -1 Policy declaration. The legislature finds that

epilepsy is a devastating health condition that afflicts

epilepsy is a devastating health condition that afflicts 2,300,000 United States citizens and over fifteen thousand in Hawaii. The legislature also finds that epilepsy afflicts its victims at all ages, but is particularly devastating to children and the elderly. Epilepsy can cause serious financial, social, and emotional hardships on the victims and their families of such major consequence that it is essential for the State to develop and implement policies, plans, and programs to alleviate

15 these hardships.

16 It is the intent of this Act to establish a program for the
17 conduct of epilepsy education, awareness, and treatment

- 1 needs of the people impacted by epilepsy. Additionally, it is
- 2 the intent of the legislature to provide for the identification,
- 3 evaluation, diagnosis, referral, and treatment of victims of
- 4 this disease through a comprehensive, statewide system of
- 5 community-based services.
- 6 S -2 Duties of the department. Subject to the
- 7 availability of funds for these purposes, the department of
- 8 health shall:
- 9 (1) Assist in the development of epilepsy assistance
- 10 programs for the care and treatment of persons
- suffering from epilepsy;
- 12 (2) Institute and carry on a statewide educational
- initiative among health care professionals, teachers,
- school administrators, public health departments, and
- families, including the dissemination of information
- and the conducting of educational programs to assist
- in the early recognition and referral of persons for
- appropriate follow-up and treatment;
- 19 (3) Develop standards for determining eligibility for care
- and treatment under any epilepsy assistance program
- 21 established pursuant to this chapter. Among other
- 22 standards developed under this paragraph, candidates,

11	§ -3 Epilepsy advisory committee. (a) The epilepsy

14	director of health or the director's designee, who shall serve
15	as a nonvoting member and who shall be the co-chair of the
16	committee, and ten voting members appointed by the governor as
17	follows:
18	(1) Three members from a list of nominees submitted by the

20	(2) Three members from a list of nominees submitted by the
21	speaker of the house of representatives;

- 6 (d) The epilepsy advisory committee shall advise the
- 7 department on their duties under this chapter.
- 8 -4 Regional programs. The epilepsy advisory committee
- 9 shall submit to the department recommendations to facilitate the
- 10 establishment of regional epilepsy treatment and education
- 11 programs designed to provide community services to people with
- 12 epilepsy and their families.
- 13 § -5 Epilepsy treatment and education grants-in-aid
- 14 fund. The epilepsy treatment and education grants-in-aid fund
- 15 is created as a special fund in the state treasury. Using
- 16 appropriations from the fund, the department shall provide
- 17 grants-in-aid:
- 18 (1) To fund necessary educational activities; and
- 19 (2) For the development and maintenance of services for
- victims of epilepsy and their families, as managed
- through an epilepsy program properly staffed and
- affiliated with a national epilepsy program.
