## A BILL FOR AN ACT

RELATING TO CERTIFICATE OF NEED.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. The legislature finds that the state health	
2	planning	and development agency currently uses the following	
3	criteria	when judging the merits of an application for a	
4	certificate of need:		
5	(1)	Relationship of the proposal to the Hawaii health	
6		performance plan;	
7	(2)	The need that the population served or to be served	
8		has for the services proposed to be offered or	
9		expanded, and the extent to which all residents of the	
10		area, and in particular the elderly, low-income	
11		persons, racial and ethnic minorities, women, persons	
12		with disabilities, and other underserved groups are	
13		likely to have access to those services;	
14	(3)	In the case of a reduction, elimination, or relocation	
15		of a facility or service:	
16		(A) The need that the population presently serviced	
17		has for the service;



1		(B) The extent to which that need will be met
2		adequately by the proposed relocation or by
3		alternative arrangements; and
4		(C) The effect of the reduction, elimination, or
5		relocation of the service on the ability of the
6		elderly, low-income persons, racial and ethnic
7		minorities, women, persons with disabilities, and
8		other underserved groups to obtain needed health
9		care;
10	(4)	The applicant's compliance with federal and state
11		licensure and certification requirements;
12	(5)	The quality of the health care services proposed;
13	(6)	In the case of existing health care services or
14		facilities, the quality of care provided by those
15		facilities in the past;
16	(7)	The probable impact of the proposal on the overall
17		costs of health care services to the community;
18	(8)	The probable impact of the proposal on the costs of
19		and charges for providing health care services by the
20		applicant;
21	(9)	The immediate and long-term financial feasibility of
22		the proposal;



1	(10)	The relationship of the proposal to the existing	
2		health care system of the area;	
3	(11)	The availability of less costly or more effective	
4		alternative methods of providing services; and	
5	(12)	The availability of resources (including health	
6		personnel, management personnel, and funds for capital	
7		and operating needs) for the provision of the services	
8		proposed to be provided and the need for alternative	
9		uses of these resources as identified by the Hawaii	
10		health performance plan.	
11	The purpose of this Act is to require the state health		
12	planning and development agency to include the criterion of		
13	impacts on the community in its determination of approval or		
14	denial of an application for a certificate of need.		
15	SECTION 2. Chapter 323D, Hawaii Revised Statutes, is		
16	amended by adding a new section to be appropriately designated		
17	and to read as follows:		
18	" <u>§</u> 32	<b>3D-</b> Certificate of need; criteria. The state agency	
19	shall ado	pt rules in accordance with chapter 91 to include the	
20	criterion of impacts on the community, among any other criteria		
21	used by the state agency, in the state agency's determination of		
22	approval	or denial of an application for a certificate of need."
