A BILL FOR AN ACT

RELATING TO AGRICULTURAL LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Notwithstanding section 205-49, Hawaii Revised		
2	Statutes, or any provision of part III of chapter 205, Hawaii		
3	Revised Statutes, to the contrary, the legislature may designate		
4	important agricultural lands if it determines that the		
5	designation is necessary to conserve and protect agricultural		
6	lands, promote diversified agriculture, increase agricultural		
7	self-sufficiency, or ensure the availability of agriculturally		
8	suitable lands.		
9	The designation of important agricultural lands shall be by		
10	concurrent resolution, adopted by majority vote of the senate		
11	and the house of representatives, and shall include:		
12	(1) Tax map keys of the lands to be designated;		
13	(2) Legislative finding of qualification for designation		
14	pursuant to section 205-44, Hawaii Revised Statutes;		
15	and		
16	(3) Legislative finding that the designation is consistent		
17	with the state plan and the general, development, and		

1		community plans of the county wherein the land is
2		situated.
3	Upon	the adoption of the concurrent resolution designating
4	important	agricultural lands pursuant to this section, the land
5	use commi	ssion shall designate the lands as important
6	agricultu	ral lands.
7	SECT	ION 2. Act 183, Session Laws of Hawaii 2005, section
8	9, is ame	nded by amending subsection (a) to read as follows:
9	"(a)	It is the intent of this Act:
10	(1)	That agricultural incentive programs to promote
11		agricultural viability, sustained growth of the
12	(A)	agricultural industry, and the long-term use and
13		protection of important agricultural lands for
14		agricultural use shall be developed concurrently with
15		the process of identifying important agricultural
16		lands as required under section 2 of this Act; and
17	(2)	That, except for the designation of important
18		agricultural lands by the legislature pursuant to
19		section 1 of Act , Session Laws of Hawaii 2008, the
20		designation of important agricultural lands and
21		adoption of maps by the land use commission pursuant
22		to section 2 of this Act shall take effect only upon

1	the enactment of legislation establishing incentives
2	and protections for important agricultural lands
3	contemplated by section $[205-F]$ 205-46, Hawaii Revised
4	Statutes, and shall be satisfied by:
5	(A) Providing a declaration of satisfaction within
6	the Act that establishes incentives for important
7	agricultural lands; or
8	(B) Having the legislature adopt a concurrent
9	resolution declaring the satisfaction of
10	implementing incentives for important
11	agricultural lands by identifying the specific
12	measures or Acts that establish incentives for
13	important agricultural lands."
14	SECTION 3. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 4. In printing this Act, the revisor of statutes
17	shall insert the appropriate number of this Act in section 2 of
18	this Act.
19	SECTION 5. This Act shall take effect upon its approval;
20	provided that section 1 of this Act shall be repealed upon the
21	satisfactory enactment of incentives for important agricultural
22	lands pursuant to section 9 of Act 183, Session Laws of Hawaii

- 2 lands designated as important agricultural lands pursuant to
