A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 321, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§321- Health professional shortage areas;
5	professional liability insurance. (a) The department of health
6	shall pay a percentage of the costs of professional liability
7	insurance for a physician licensed under chapter 453 with a
8	qualified practice in a health professional shortage area of the
9	state equal to that percentage of the physician's patients
10	residing in a health professional shortage area whose services
11	are compensated by receipts from the medicaid program.
12	(b) A report shall be prepared by the department of health
13	to be presented annually to the legislature not less than twenty
14	days prior to the start of each regular session, beginning with
15	the 2009 regular session. The report shall include:
16	(1) The annual costs incurred by providing professional
17	liability insurance to physicians with an established

1		practice in a health professional shortage area of the
2		state;
3	(2)	Any increase or decrease in the number or physicians
4		establishing practices in health professional shortage
5		areas of the state that can be attributed to this
6		section; and
7	(3)	Any recommendations and proposed legislation.
8	(c)	The department of health shall adopt rules pursuant to
9	chapter 9	1 to implement this section.
10	(d)	As used in this section:
11	<u>"Hea</u>	lth professional shortage area" means areas of the
12	state des	ignated by the Health Resources and Services
13	Administr	ation of the United States Department of Health and
14	Human Ser	vices as having shortages of primary medical care,
15	dental ca	re, or mental health care providers.
16	"Qua	lified practice" means a practice at which fifty per
17	cent or m	ore of the total amount received for services at that
18	practice	for the taxable year are receipts from the medicaid
19	program a	nd fifty per cent or more of the patients whose
20	services	are compensated by receipts from the medicaid program
21	reside in	a health professional shortage area.

         "§663-1.5 Exception to liability. (a) Any person who in

    good faith renders emergency care, without remuneration or

    expectation of remuneration, at the scene of an accident or

    emergency to a victim of the accident or emergency shall not be

    liable for any civil damages resulting from the person's acts or

    omissions, except for such damages as may result from the

    person's gross negligence or wanton acts or omissions.

              No act or omission of any rescue team or physician

    working in direct communication with a rescue team operating in

    conjunction with a hospital or an authorized emergency vehicle

- 8 damages, if the physician exercises that standard of care

- 11 this state or any other state practicing medicine as provided
- 12 under chapter 453, in a health professional shortage area of the
- 13 state, shall not be liable for any civil damages, if the
- 14 physician exercises that standard of care expected of similar
- 15 physicians under similar circumstances.
- 16 As used in this subsection, "health professional shortage
- 17 area" means areas of the state designated by the Health
- 18 Resources and Services Administration of the United States
- 19 Department of Health and Human Services as having shortages of
- 20 primary medical care, dental care, or mental health care

- 1 "Good faith" includes but is not limited to a reasonable
- 2 opinion that the immediacy of the situation is such that the
- 3 rendering of care should not be postponed.
- 4 "Rescue team" means a special group of physicians, basic
- 5 life support personnel, advanced life support personnel,
- 6 surgeons, nurses, volunteers, or employees of the owners or
- 7 operators of the hospital or authorized emergency vehicle who
- 8 have been trained in basic or advanced life support and have
- 9 been designated by the owners or operators of the hospital or
- 10 authorized emergency vehicle to attempt to provide such support
- 11 and resuscitate persons who are in immediate danger of loss of
- 12 life in cases of emergency."
- 13 SECTION 3. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2008-2009 for
- 16 professional liability insurance for physicians who establish a
- 17 practice in a health professional shortage area of the state.
- 18 The sum appropriated shall be expended by the department of
- 19 health for the purposes of this Act.

- 21 and stricken. New statutory material is underscored.
