### A BILL FOR AN ACT

RELATING TO RECREATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to create the 2 University of Hawaii stadium corporation and transfer 3 jurisdiction over Aloha Stadium to the corporation. The primary 4 duty of the stadium corporation is to operate, maintain, manage, and improve Aloha Stadium with the University of Hawaii as the 5 6 major tenant. The secondary duty is to generate net income from 7 Aloha Stadium that may be transferred to the intercollegiate 8 athletics program of the University of Hawaii. The stadium 9 corporation is to be headed by a board of directors consisting 10 of eleven members. One member is to be the University of Hawaii 11 president. Five members are to be appointed by the University 12 board of regents without necessity of senate confirmation. Five 13 other members are to be appointed by the governor, subject to 14 the confirmation of the senate. All appointed members are 15 required to have experience in business, marketing, accounting, 16 economics, engineering, architecture, or sports administration. 17 The stadium corporation is provided with certain autonomy and 18



flexibility to perform its duties.

- 1 The legislature finds that Aloha Stadium is a public asset
- 2 with major structural deficiencies, yet untapped potential. The
- 3 legislature further finds that transferring jurisdiction over
- 4 Aloha Stadium to a public body with corporate powers is in the
- 5 public interest. The legislature believes that such a
- 6 corporation would be better able to maximize the usage and,
- 7 consequently, income of Aloha Stadium and generate support for
- 8 the capital improvement of Aloha Stadium to extend its useful
- 9 life substantially. The legislature also believes that placing
- 10 Aloha Stadium under a corporation may result in the generation
- 11 of net income transferable to the University of Hawaii's
- 12 intercollegiate athletics program.
- 13 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 14 amended by adding a new subpart to part VII to be appropriately
- 15 designated and to read as follows:
- 16 " . University of Hawaii Stadium Corporation
- 17 §304A-A University of Hawaii stadium corporation;
- 18 creation. There is established as a body corporate the
- 19 University of Hawaii stadium corporation. The corporation shall
- 20 be a public instrumentality and shall be a part of the
- 21 University of Hawaii for administrative purposes pursuant to
- 22 section 26-35.

1 §304A-B Duties of stadium corporation. (a) The stadium 2 corporation shall have the primary duty of maintaining, 3 operating, managing, and improving Aloha Stadium with the 4 University of Hawaii as the major tenant. The stadium 5 corporation shall perform this duty within the limits of 6 available legislative appropriations. 7 The stadium corporation shall have the secondary duty 8 of generating net income that may be transferred to the 9 intercollegiate athletics program of the University of Hawaii. 10 §304A-C Stadium corporation board of directors. 11 stadium corporation shall be under the general management and 12 control of a board of directors. 13 The board of directors shall consist of eleven 14 members. The president of the university shall serve as an ex 15 officio, voting member. Five members shall be appointed by the 16 board of regents without necessity of confirmation by the 17 senate. Five other members shall be appointed by the governor pursuant to section 26-34. All appointed members shall be 18 19 appointed to four-year terms commencing on July 1 and expiring on June 30; except that two of the initial appointees of each 20 21 appointing authority shall be appointed to two-year terms. All 22 appointed members shall have experience in business, marketing,

- 1 accounting, economics, engineering, architecture, or sports
- 2 administration.
- 3 (c) No person shall be appointed consecutively to more
- 4 than two full terms as a member of the board of directors.
- 5 (d) When an appointed member vacates the member's seat on
- 6 the board of directors, the vacancy shall be filled for the
- 7 remainder of the unexpired term in the same manner as the
- 8 original appointment.
- 9 (e) The officers of the board of directors shall be
- 10 elected by the members.
- (f) Members of the board of directors shall serve without
- 12 compensation, but shall be entitled to reimbursement for
- 13 necessary expenses, including travel expenses, while attending
- 14 meetings and discharging official duties and responsibilities.
- 15 (g) The board of directors may adopt, amend, and repeal
- 16 bylaws under chapter 91 governing the conduct of its business
- 17 and the exercise of its powers.
- 18 §304A-D Powers of stadium corporation. To perform its
- 19 duties, the stadium corporation, under the direction of the
- 20 board of directors, shall have the following powers:
- 21 (1) To have a corporate seal;
- 22 (2) To sue and be sued in its own name;

10	(5)	To make and execute contracts and other instruments
11		with other government agencies and private persons;
12	(6)	To adopt, amend, and repeal rules in accordance with

14	. (7)	To promote and market Aloha Stadium;
15	(8)	To solicit and accept gifts, grants, devises, or
16		bequests for Aloha Stadium;
17	(9)	To serve as trustee or beneficiary under the terms of
18		any gift, indenture, or bequest; and
19	(10)	To do any or all other acts reasonably necessary to
20		carry out its duties and the purposes of this subpart
21	§304	A-E Officers and employees of the stadium corporation
22	(a) The	ooard of directors shall appoint a stadium manager and

- 1 deputy stadium manager, each of whom shall have such
  2 qualifications as the board deems necessary. The stadium
- 3 manager and deputy stadium manager shall serve at the pleasure
- 4 of the board and shall be exempt from chapters 76 and 89, but
- 5 shall be entitled to participate in any employee benefit program
- 6 generally applicable to employees of the State. The board of
- 7 directors shall set the salaries of the stadium manager and
- 8 deputy stadium manager. The stadium manager shall serve as the
- 9 chief executive officer of the stadium corporation and
- 10 administer Aloha Stadium, subject to the direction of the board.
- 11 The deputy stadium manager shall be the first assistant to the
- 12 stadium manager, perform all duties assigned by the stadium
- 13 manager, and serve as acting stadium manager in the absence of
- 14 the stadium manager.
- 15 (b) The stadium manager shall appoint such other officers
- 16 and employees as may be authorized by the board of directors to
- 17 administer the stadium corporation. The board of directors
- 18 shall set the salaries of the officers and employees. The
- 19 officers and employees shall serve at the pleasure of the
- 20 stadium manager, and shall be exempt from chapters 76 and 89,
- 21 but shall be entitled to participate in any employee benefit
- 22 program generally applicable to employees of the State.



- 1 (c) Each employee holding a permanent appointment to a 2 civil service position under the former stadium authority as of 3 July 1, 2008, shall continue in the position. Those employees 4 shall continue to be subject to chapter 76 and, if applicable, chapter 89 until vacating the position. 5 6 §304A-F Aloha Stadium special fund. (a) There is created 7 the Aloha Stadium special fund within the treasury of the State. 8 The following shall be deposited into the special (b) 9 fund:
- 10 (1) Income earned by the stadium corporation from fees and that charges for the use of Aloha Stadium;
- 12 (2) Interest earned on moneys in the special fund; and
- 13 (3) Any legislative appropriations.
- 14 (c) Moneys in the Aloha Stadium special fund shall be
  15 appropriated and expended to operate, maintain, manage, and
  16 improve Aloha Stadium and, if required by the legislature, to
  17 reimburse the general fund for debt service paid on general
  18 obligation bonds issued for capital improvement projects for
  19 Aloha Stadium.
- 20 Moneys in the special fund shall not be appropriated or 21 expended to pay debt service on any revenue bonds.

1 (d) In addition to subsection (c), unappropriated and 2 unencumbered moneys in the special fund that the board of 3 directors determines are not necessary to be retained as 4 reserves may be transferred to the University of Hawaii for its 5 intercollegiate athletics program. A transfer of such 6 unappropriated and unencumbered moneys shall be approved by the 7 board of directors without necessity of approval by the board of 8 regents, university president, director of finance, or 9 legislature. 10 Nothing in this section or this subpart shall be 11 construed as prohibiting the appropriation and expenditure of 12 other moneys, such as general funds or general obligation bond 13 funds, for Aloha Stadium. 14 \$304A-G Fees and charges. In establishing or amending 15 fees and charges for the use of Aloha Stadium, the stadium 16 corporation shall be exempt from chapter 91. The stadium 17 corporation, however, shall establish or amend the fees and 18 charges at an open meeting held in conformance with chapter 92. 19 §304A-H Funding of capital improvement projects for Aloha 20 (a) Debt service on general obligation bonds for

capital improvement projects for Aloha Stadium that were issued

- 1 before the effective date of this Act shall be paid from the
- 2 general fund.
- 3 (b) After the effective date of this Act, capital
- 4 improvement projects for Aloha Stadium shall be funded by the
- 5 Aloha Stadium special fund or general obligation bonds. The
- 6 legislature shall use its discretion to determine whether the
- 7 debt service on the general obligation bonds should be
- 8 reimbursed by the Aloha Stadium special fund or paid only with
- 9 general funds.
- 10 (c) No revenue bonds shall be authorized or issued to fund
- 11 any capital improvement project for Aloha Stadium.
- 12 §304A-I Payments from Aloha Stadium special fund. Moneys
- 13 appropriated by the legislature from the Aloha Stadium special
- 14 fund shall be payable by the director of finance upon vouchers
- 15 approved by the stadium manager.
- 16 §304A-J Security personnel, powers. The person employed
- 17 as the chief security officer for Aloha Stadium by the stadium
- 18 corporation shall have all of the powers of a police officer,
- 19 including the power of arrest; provided that such powers shall
- 20 be in force and effect only while the person is in the actual
- 21 performance of the person's duties at Aloha Stadium.



\$304A-K Enforcement; penalty. (a) Any law enforcement 1 2 officer who has police powers to arrest offenders and issue 3 citations shall have the authority to enforce any rule adopted 4 by the stadium corporation. (b) Except as otherwise provided under subsection (c), any 5 6 person violating any rule of the stadium corporation regulating 7 conduct at Aloha Stadium shall be quilty of a petty misdemeanor. 8 (c) Any person violating any rule of the stadium 9 corporation regulating parking or traffic at Aloha Stadium shall 10 have committed a traffic infraction as set forth in chapter 11 291D, the adjudication of which shall be subject to the provisions of that chapter." 12 13 SECTION 3. Chapter 304A, Hawaii Revised Statutes, is amended by adding a new section to part V, subpart C, to be 14 15 appropriately designated and to read as follows: 16 "\$304A- Aloha Stadium special fund. The Aloha Stadium 17 special fund shall be subject to part VII, subpart ." 18 SECTION 4. Section 37-35, Hawaii Revised Statutes, is 19 amended to read as follows:
