## A BILL FOR AN ACT

RELATING TO CRUELTY TO ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 711, Hawaii Revised Statutes, is		
2	amended by adding a new section to be appropriately designated		
3	and to read as	follows:

5	(1) (a)	No person shall cause, sponsor, arrange, hold, or

12	<u>(ii)</u>	Owns, trains, transports, possesses, breeds,	
13		sells, transfers, or equips a dog with the intent

15	<u>(iii)</u>	Knowingly allows a dog fight to occur on any	
16		property owned or controlled by the person;

3		(v) Knowingly uses any means of communication for the
4		purpose of promoting a dog fight; or
5		(vi) Knowingly possesses any dog used for a fight or

8	(2)	Nothing in this section shall prohibit any of the

10	<u>(a)</u>	The use of dogs in the management of livestock by the
11		owner of the livestock or the owner's employees or
12		agents or other persons in lawful custody thereof;
13	<u>(b)</u>	The use of dogs in hunting wildlife including game; or
14	<u>(c)</u>	The training of dogs or the use of equipment in the
15		training of dogs for any purpose not prohibited by
16		law.
17	(3)	Dog fighting is a class C felony. Any person

13	matured, penalties that were incurred, and proceedings that were		
14	begun, before its effective date.

17	SECTION 5. This Act shall take effect upon its approval.

Crimes; Dog Fighting

### Description:

Repeals existing prohibition against dog fighting and enacts more comprehensive prohibition of dog fighting and related conduct. Provides enhanced penalties.
