## A BILL FOR AN ACT

RELATING TO CRUELTY TO ANIMALS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTIO	N 1. Chapter 711, Hawaii Revised Statutes, is	
2	amended by adding a new section to be appropriately designated		
3	and to read	as follows:	
4	<u>"§711-</u>	Dog fighting. (1) A person commits the offense	
5	of dog figh	ting if the person causes, sponsors, arranges, holds,	
6	or encourag	es a fight between dogs for the purpose of monetary	
7	gain or ent	ertainment, including:	
8	<u>(a)</u> <u>K</u>	nowingly wagering on a dog fight;	
9	<u>(b)</u> 0	wning, training, transporting, possessing, breeding,	
10	<u>s</u>	elling, transferring, or equipping a dog with the	
11	<u>i</u>	ntent that the dog will be engaged in a fight;	
12	<u>(c)</u> <u>K</u>	nowingly allowing a dog fight to occur on any	
13	р	roperty owned or controlled by the person;	
14	<u>(d)</u> <u>K</u>	nowingly allowing any dog intended by the person to	
15	<u>b</u>	e used for a fight to be kept, boarded, housed,	
16	<u>t</u>	rained on, or transported in, any property owned or	
17	C	ontrolled by the person;	

1	<u>(e)</u>	Knowingly using any means of communication for the
2		promotion of dog fighting; or
3	<u>(f)</u>	Knowingly possessing any dog intended by the person to
4		be used for a fight or any device intended to enhance
5		the animal's fighting ability. As used in this
6		paragraph, "device" means both animate and inanimate
7		objects and includes live animals used as bait
8		animals.
9	(2)	Nothing in this section shall prohibit any of the
10	following	<u>:</u>
11	<u>(a)</u>	The use of dogs in the management of livestock by the
12		owner of the livestock, the owner's employees or
13		agents, or other persons in lawful custody thereof;
14	<u>(d)</u>	The use of dogs in hunting wildlife, including game;
15		<u>or</u>
16	<u>(c)</u>	The training of dogs or the use of equipment in the
17		training of dogs for any purpose not prohibited by
18		<u>law.</u>
19	(3)	Dog fighting is a class C felony. Any person
20	committin	g a second or subsequent offense under this section
21	shall be	sentenced to:

1	<u>(a)</u>	An indeterminate term of imprisonment of five years,
2		pursuant to section 706-660; or
3	(b)	Five years probation, with conditions to include a
4		term of imprisonment of no fewer than thirty days
5		without possibility of suspension of sentence.
6	(4)	If there is any conflict between this section and
7	sections	711-1108.5, 711-1109, or any other provision of law,
8	this sect	ion shall apply."
9	SECT	ION 2. Section 711-1109.3, Hawaii Revised Statutes, is
10	repealed.

17		fight with another dog, or causes any dog to injure
18		another dog; or
19	<del>(c)</del>	Knowingly or recklessly permits any act in violation
20		of paragraph (a) or (b) to be done on the premises
21		under the person's charge or control, or aids or abets
22		any such act.
