A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to address the

2 repair and maintenance of facilities of the University of

3 Hawaii. More specifically, this Act:

- (1) Creates the University of Hawaii repair and maintenance special account to fund the repair and
- 6 maintenance of university facilities and requires the

7 deposit of one per cent of general revenues accrued

during the next six fiscal years into the special

account; and

10 (2) Expresses the legislature's intent to authorize and

11 appropriate, in each of the next six fiscal years, an

additional minimum of \$50,000,000 in general

obligation bonds for the same purpose and requires

general excise tax revenues to be transferred to the

University of Hawaii repair and maintenance special

account if the minimum \$50,000,000 general obligation

bond commitment falls short in any fiscal year.

1	The legislature has expressed only its intent for future
2	authorizations and appropriations of a minimum \$50,000,000 in
3	general obligation bonds because the legislature is unable to
4	make the actual appropriation for future fiscal years in this
5	Act. The Hawaii Constitution requires moneys for executive
6	agencies to be appropriated only in the executive budget act,
7	supplemental budget act, or another act passed subsequent to
8	either of the former. Thus, this Act cannot make appropriations
9	for fiscal years beyond fiscal year 2008-2009.
10	This Act also:
11	(1) Requires certain appropriations to be made in lump
12	sums to give the University of Hawaii the discretion
13	to identify the repair and maintenance projects to be
14	funded;
15	(2) Appropriates \$50,000,000 from the University of Hawaii
16	repair and maintenance special account for repair and
17	maintenance of university facilities; and
18	(3) Authorizes the issuance of \$50,000,000 in general
19	obligation bonds and appropriates the proceeds for the
20	same purpose.

- 1 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 2 amended by adding a new subpart to part VI to be appropriately
- 3 designated and to read as follows:
- 4 " . GENERAL OBLIGATION BONDS FOR REPAIR AND MAINTENANCE
- 5 §304A-A Legislative intent concerning general obligation
- 6 bonds for repair and maintenance. (a) The legislature
- 7 expresses its intent to authorize and appropriate, during each
- 8 fiscal year of the fiscal period from July 1, 2008, through June
- 9 30, 2014, general obligation bonds in the sum of not less than
- 10 \$50,000,000 for the repair and maintenance of University of
- 11 Hawaii facilities; provided that each appropriation shall be in
- 12 a lump sum to allow the University of Hawaii full discretion in
- 13 identifying the repair and maintenance projects to be funded.
- 14 (b) If in any fiscal year for which subsection (a)
- 15 applies, the legislature fails or refuses to fulfill the intent
- 16 expressed under that subsection, general excise tax revenues in
- 17 an amount determined in accordance with section 237-31(2) shall
- 18 be credited to the University of Hawaii repair and maintenance
- 19 special account during that fiscal year."
- 20 SECTION 3. Chapter 36, Hawaii Revised Statutes, is amended
- 21 by adding a new section to part II to be appropriately
- 22 designated and to read as follows:

1	Expe	nditures from the special account shall be subject to
2	sections	37-31 and 37-33 to 37-40.
3	<u>(d)</u>	Any unexpended and unencumbered appropriation at the
4	close of	the fiscal period for which the appropriation is made
5	shall lap	se into the special account and be available for
6	appropria	tion and expenditure in subsequent fiscal years.
7	<u>(e)</u>	This section shall not be construed to prohibit:
8	(1)	The appropriation and expenditure of other sources of
9		funds, such as general obligation bond funds, for the
10		repair and maintenance of University of Hawaii
11		facilities; or
12	(2)	The appropriation and expenditure of general funds,
13		general obligation bonds, or other sources of funds
14		for the development of new University of Hawaii
15		facilities.
16	<u>(f)</u>	Beginning with the regular session of 2009, the
17	president	of the University of Hawaii shall submit an annual
18	report to	the legislature no later than twenty days prior to the
19	convening	of each regular session. The report shall include:
20	(1)	A financial statement of the University of Hawaii
21		repair and maintenance special account;

1	(2)	The repair and maintenance projects undertaken during						
2		the immediate past fiscal year; and						
3	(3)	The planned repair and maintenance projects for the						
4		remaining fiscal years during which the special						
5		account is to receive moneys.						
6	(g)	No general revenues of the State that accrue after						
7	June 30,	2014, shall be deposited into the special account.						
8	No general excise tax revenues shall be deposited into the							
9	special account after June 30, 2014.							
10	(h) This section shall be repealed on the day following							
11	the date of the last payment of moneys from the special account							
12	The attorney general, upon the advice of the director of							
13	finance, shall notify the president of the senate, speaker of							
14	the house	of representatives, and revisor of statutes of the						
15	date of the repeal."							
16	SECTION 4. Section 237-31, Hawaii Revised Statutes, is							
17	amended to read as follows:							
18	"§23	7-31 Remittances. All remittances of taxes imposed by

- 3 SECTION 6. There is appropriated out of the University of
- 4 Hawaii repair and maintenance special account in the general
- 5 fund of the State of Hawaii the sum of \$50,000,000 or so much
- 6 thereof as may be necessary for fiscal year 2008-2009 for the
- 7 repair and maintenance of University of Hawaii facilities as
- 8 identified by the University of Hawaii; provided that the
- 9 appropriation made by this section shall not lapse at the end of
- 10 the fiscal year for which the appropriation is made; provided
- 11 further that all moneys from the appropriation unencumbered as
- 12 of June 30, 2010, shall lapse back into the University of Hawaii
- 13 repair and maintenance special account as of that date.
- 14 The sum appropriated shall be expended by the University of
- 15 Hawaii for the purposes of this section.
- 16 SECTION 7. The director of finance is authorized to issue
- 17 general obligation bonds in the sum of \$50,000,000 or so much
- 18 thereof as may be necessary and the same sum or so much thereof
- 19 as may be necessary is appropriated for fiscal year 2008-2009
- 20 for the repair and maintenance of University of Hawaii
- 21 facilities as identified by the university; provided that the
- 22 appropriation made by this section shall not lapse at the end of

- 1 the fiscal year for which the appropriation is made; provided
- 2 further that all moneys from the appropriation unencumbered as
- 3 of June 30, 2010, shall lapse as of that date.
- 4 The sum appropriated shall be expended by the University of
- 5 Hawaii for the purposes of this section.
- 6 SECTION 8. In codifying the new sections added by sections
- 7 2 and 3 of this Act, the revisor of statutes shall substitute
- 8 appropriate section numbers for the letters used in designating
- 9 the new sections in this Act.
- 10 SECTION 9. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 10. This Act shall take effect on June 29, 2020;
- 13 provided that:
- 14 (1) The amendment made to section 237-31, Hawaii Revised
- 15 Statutes, by section 4 of this Act shall not be
- 16 repealed when that section is repealed and reenacted
- on June 30, 2008, by section 4 of Act 304, Session
- 18 Laws of Hawaii 2006; and
- 19 (2) The amendment made to section 237-31, Hawaii Revised
- 20 Statutes, by section 4 of this Act shall be repealed
- on June 30, 2014.

Report Title:

University of Hawaii Facilities; Repair and Maintenance

Description:

Requires 1 percent of general revenues accrued from July 1, 2008, to June 30, 2014, to be deposited into the newly-created University of Hawaii Repair and Maintenance Special Account for the repair and maintenance of UH facilities. Expresses the Legislature's intent to authorize and appropriate, in each fiscal year of the fiscal period July 1, 2008, to June 30, 2014, at least an additional \$50,000,000 in general obligation bonds for the repair and maintenance of UH facilities. Provides that, if the \$50,000,000 in bonds is not appropriated in a fiscal year, general excise tax revenues to make up the shortfall shall be automatically transferred to the special account. that the appropriations of special account moneys and general obligation bond funds shall be in lump sums so that UH has the discretion to identify the repair and maintenance projects that should be funded. Appropriates \$50,000,000 from the special account in fiscal year 2008-2009 for the repair and maintenance of UH facilities. Authorizes and appropriates \$50,000,000 in general obligation bonds for the repair and maintenance of UH facilities. (HB2521 HD2)
