## A BILL FOR AN ACT

RELATING TO YOUTH PROGRAMS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Palolo outreach program is sponsored by the
- 2 Kaimuki-Waialae Young Men's Christian Association and, in
- 3 coordination with other youth outreach programs also based in
- 4 Palolo Valley, works with two elementary and one middle school
- 5 to provide services to lower-income, at-risk youth. The program
- 6 identifies youth in need of support and offers them
- 7 opportunities in the areas of academic monitoring and tutoring,
- 8 English as second language tutoring, various team sports, and
- 9 club programs such as cooking and hiking. Special monthly
- 10 activities are hosted that are designed to expose the youth to
- 11 new experiences. The program reinforces in its participants the
- 12 values of mutual respect, a sense of responsibility, honesty,
- 13 cooperation, diligence, and good sportsmanship.
- 14 The purpose of this Act is to appropriate funds to support
- 15 the operations of the Palolo outreach program.
- 16 SECTION 2. There is appropriated out of temporary
- 17 assistance for needy families funds the sum of \$97,594 or so

- 1 much thereof as may be necessary for fiscal year 2008-2009 to
- 2 support the operations of the Palolo outreach program.
- 3 The sum appropriated shall be expended by the department of
- 4 human services for the purpose of this Act.
- 5 SECTION 3. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$97,594 or so much
- 7 thereof as may be necessary for fiscal year 2008-2009 to support
- 8 the operations of the Palolo outreach program.
- 9 The sum appropriated shall be expended by the department of
- 10 human services from the temporary assistance for needy families
- 11 funds for the purpose of this Act; provided that, prior to
- 12 expending any moneys appropriated in this section, the
- 13 department of human services shall first attempt to obtain
- 14 federal approval to utilize the moneys appropriated in section 2
- 15 for the purpose of this Act. If the federal government denies,
- 16 in writing, the department of human services' request to utilize
- 17 temporary assistance for needy families funds for the purpose of
- 18 this Act, then the moneys appropriated in this section may be
- 19 expended. If the federal government approves, in writing, the
- 20 use of temporary assistance for needy families funds for the
- 21 purpose of this Act, then the moneys appropriated in this

- 1 section shall immediately lapse to the credit of the general
- 2 fund.
- 3 SECTION 4. This Act shall take effect on July 1, 2008.
