A BILL FOR AN ACT

RELATING TO IMMUNIZATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 302A-1154, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 [No] A child [shall] may attend any school in the 4 State [unless] if the child presents to the appropriate school 5 official documentation satisfactory to the department of health 6 that the child has received immunizations against communicable diseases as [required] recommended by the department of 7 8 health[-]; provided that any parent, custodian, guardian, or any 9 other person in loco parentis to a child may object to 10 immunization on any grounds pursuant to section 302A-1156, and 11 upon showing the appropriate school official satisfactory evidence of the exemption, no certificate or other evidence of 12 13 immunization shall be required for the child's entry into 14 school." SECTION 2. Section 302A-1155, Hawaii Revised Statutes, is 15 16 amended to read as follows: 17 "\$302A-1155 Provisional entrance to school. (a) A child
- 18 may enter school provisionally upon submitting written HB LRB 08-0804.doc

- 1 documentation from a licensed physician, advanced practice
- 2 registered nurse, or an authorized representative of the
- 3 department of health, stating that the child is in the process
- 4 of receiving the [required] recommended immunizations. Further
- 5 documentation showing that the [required] recommended
- 6 immunizations have been completed shall be submitted to the
- 7 appropriate school official no later than three months after the
- 8 child first entered the school. If all of the [required]
- 9 recommended immunizations cannot be completed within three
- 10 months due to the length of the minimum intervals between doses
- 11 of a particular vaccine [required] recommended by the department
- 12 of health, provisional admission may be extended so long as the
- 13 child's parent or guardian provides documentation that
- 14 appointments for [required] recommended immunizations have been
- 15 made and that progress toward completing the immunizations
- 16 continues in accordance with the requirements of the department
- 17 of health.
- 18 (b) Provisional entrance to school may be suspended by the
- 19 department of health when there is danger of an epidemic from
- 20 any of the communicable diseases for which immunization is
- 21 [required.] recommended."



- 1 SECTION 3. Section 302A-1156, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+]\$302A-1156[+] Exemptions. A child may be exempted 4 from the [required] recommended immunizations: 5 (1)If a licensed physician certifies that the physical 6 condition of the child is such that immunizations 7 would endanger the child's life or health; or 8 If any parent, custodian, guardian, or any other (2)9 person in loco parentis to a child objects to 10 immunization in writing on any grounds, including the 11 grounds that the immunization conflicts with that 12 person's bona fide religious tenets and practices. 13 Upon showing the appropriate school official 14 satisfactory evidence of the exemption, no certificate or other evidence of immunization shall be required 15 16 for the child's entry into school." SECTION 4. Section 302A-1157, Hawaii Revised Statutes, is 17 18 amended to read as follows: 19 "[+]\$302A-1157[+] Exemptions from immunization; not 20 recognized; epidemic conditions. - 5 SECTION 9. Section 325-33, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "\$325-33 Performance of vaccination and immunization.
- 8 Vaccinations or immunizations [required of] recommended for any
- 9 person under this chapter shall be performed by duly licensed
- 10 physicians or paramedical personnel under their direction,
- 11 advanced practice registered nurses, or by authorized
- 12 representatives of the department of health. A record of the
- 13 immunization shall be maintained by the physician or advanced
- 14 practice registered nurse and shall be available to the
- 15 department of education for school entry requirements and the
- 16 department of health."
- 17 SECTION 10. Section 325-34, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "\$325-34 Exemptions. (a) Section 325-32 shall be
- 20 construed not to require the vaccination or immunization of any
- 21 person for three months after a duly licensed physician or an
- 22 authorized representative of the department of health has signed

- 2 person and that because of a stated cause the health of the
- 3 person would be endangered by the vaccination or immunization,
- 4 and has forwarded the original copy of the certificate to the
- 5 person or, if the person is a minor or under guardianship, to

- 7 duplicate copy of the certificate to the department for its

- 9 (b) No person shall be subjected to vaccination,

Vaccinations; Exemptions Allowed on Any Grounds

Description:

Makes all vaccinations in the State non-compulsory but only recommended unless there is danger of an epidemic from any communicable disease. Allows exemptions from vaccinations on any grounds.
