A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTI	ION 1. When the federal weed and seed initiative was	
2	in effect	at Mayor Wright homes public housing complex several	
3	years ago,	, residents saw a significant improvement in their	
4	neighborho	ood. However, the conditions at Mayor Wright homes	
5	public housing complex have deteriorated. The complex was		
6	recently t	the site of a shooting, and has experienced	
7	disturbances between the tenants and their neighbors. In		
8	addition, there have been several instances of public		
9	drunkenness and excessive noise.		
10	The purpose of this Act is to:		
11	(1)	Improve security measures at Mayor Wright homes public	
12		housing complex by appropriating funds for the	
13		contract hiring of at least three security officers;	
14		and	
15	(2)	Require the Hawaii public housing authority to submit	
16		a report to the legislature on the progress of	
17		security improvements at Mayor Wright homes public	
18		housing complex.

2	submit a	report to the legislature no later than twenty days
3	prior to	the convening of the 2009 regular session on the
4	progress	of security improvements at Mayor Wright homes public
5	housing c	complex, including:
6	(1)	The actions taken to improve the safety and security
7		of the residents of Mayor Wright homes;
8	(2)	The plans made with the management of Mayor Wright
9		homes, its tenants, and other stakeholders to further
10		improve security at Mayor Wright homes;
11	(3)	An estimate of the number of additional security
12		officers required to ensure the safety of the tenants
13		and guests of Mayor Wright homes on a twenty-four hour
14		basis; and
15	(4)	Any other findings and recommendations, including
16		proposed legislation, regarding the security situation
17		at Mayor Wright homes.
18	SECT	ION 3. There is appropriated out of the general
19	revenues	of the State of Hawaii the sum of \$235,582 or so much
20	thereof a	s may be necessary for fiscal year 2008-2009 for the
21	contract	hiring of at least three security officers at Mayor
