# A BILL FOR AN ACT

RELATING TO WOMEN'S HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that improving the health 2 of women in the state can improve the quality of health for families and the community. Nationwide, more than twenty 3 4 million low-income women receive health coverage and long-term 5 care through medicaid, the nation's public health insurance 6 program for the low-income population. Although medicaid is not 7 typically considered a women's health program, sixty-nine per cent of its adult beneficiaries are women. Medicaid provides a 8 9 wide range of health services for women including primary care, 10 pregnancy care, reproductive health care, care for chronic 11 conditions and disabilities, assistance with medicare costs, and 12 long-term care. In general, compared to the total population, 13 women participants in the medicaid program tend to be poor, 14 minorities, and mothers. In Hawaii, the medicaid program is 15 implemented through the QUEST program.

16 According to data on 52,932 women in Hawaii who gave birth 17 to children from 2004 to 2006, women under Hawaii's QUEST health 18 insurance program were, compared with other women who have HB2761 HD1 HMS 2008-1565

3	(1)	Three times less likely to access prenatal care in the	
4		first trimester of pregnancy;	
5	(2)	Just as likely to have their infants receive their	
6		first well-baby check, but are twice as likely not to	
7		have received the recommended post-partum check for	
8		new mothers;	
9	(3)	One-and-a-half times more likely to have an unintended	
10		pregnancy;	
11	(4)	At three to four times and two to three times higher	
12		risk of being abused before becoming pregnant by their	
13		former and current spouses, respectively;	
14	(5)	At three to four times higher risk of experiencing	
15		intimate partner violence while pregnant;	
16	(6)	One-and-a-half times more likely to require dental	
17		services during pregnancy;	
18	(7)	Three times more likely to smoke during the last three	
19		months of pregnancy;	
20	(8)	Three to four times more likely to use illicit drugs	
21		during pregnancy;	
22	(9)	Twice as likely to experience post-partum depression;

1	(10) Twice as likely not to have initiated breastfeeding;		
2	and		
3	(11) Ten per cent more likely to have a low birthweight or		
4	premature infant.		
5	The legislature also finds that pregnancies that recur		
6	within a short period of time place great stress on mothers and		
7	their infants. Interconception care, or the full scope of		
8	preventive and primary care services for women between		
9	pregnancies, provides additional intensive interventions to		
10	women who have had a previous pregnancy that ended in an adverse		
11	outcome, which is an important predictor of future reproductive		
12	risk.		
13	The purpose of this Act is to extend post-partum and		
14	interconception care from eight weeks to six months for all		
15	women of childbearing age who participate in Hawaii's QUEST		
16	program.		
17	SECTION 2. Chapter 346, Hawaii Revised Statutes, is		
18	amended by adding a new section to be appropriately designated		
19	and to read as follows:		
20	"§346- QUEST program; post-partum and interconception		
21	care; definition; rules. (a) Each female participant of		
22	childbearing age under the QUEST program shall be provided with

1	not less than six months of post-partum and interconception
2	care.
3	(b) For the purpose of this section, the term
4	"interconception care" means the full scope of preventive and
5	primary care services for women between pregnancies.
6	(c) Notwithstanding any law to the contrary, the
7	department shall make appropriate adjustments to the "rate of
8	payment per participating recipient" amount paid to health
9	maintenance organizations and prepaid health plans pursuant to
10	section 346-59(d), to allow for post-partum and interconception
11	care coverage to QUEST recipients as defined in section 346-
12	, administered by a person licensed to practice medicine under
13	chapter 453. Health maintenance organizations and prepaid
14	health plans shall not be required to increase coverage to QUEST
15	recipients for post-partum and interconception care administered
16	to QUEST recipients, as defined in section 346- ,
17	administered by a person licensed to practice medicine under
18	chapter 453, until the department makes adjustments to the "rate
19	of payment per participating recipient" amounts.
20	(d) The department shall adopt rules to implement the
21	purposes of this section, including determining the age range of
22	childbearing women."

1	SECTION 3. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so
3	much thereof as may be necessary for fiscal year 2008-2009 for
4	providing not less than six months of post-partum and
5	interconception care for women of childbearing age who
6	participate in Hawaii's QUEST program.
7	The sum appropriated shall be expended by the department of
8	human services for the purposes of this Act.
9	SECTION 4 New statutory material is underscored.
10	SECTION 5. This Act shall take effect upon its approval,
11	except that section 3 shall take effect on July 1, 2008.
