# A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 89C, Hawaii Revised Statues, provides

2 an appropriate authority, including the board of education, with

3 sufficient flexibility to adjust the wages, hours, benefits, and

4 other terms and conditions of employment for employees who are

5 excluded from collective bargaining. However, the appropriate

6 authority may not adjust the wages of employees who are included

7 in collective bargaining. The legislature finds that substitute

8 teachers are part-time, casual, and intermittent employees who

9 are excluded from collective bargaining.

10 The purpose of this Act is to require the board of

11 education to provide wage adjustments for substitute teachers

12 comparable to the wage adjustments negotiated for teachers in

13 collective bargaining unit 5, and to allow the board of

education to adjust the hours, benefits, and other terms and

conditions of employment for substitute teachers.

16 SECTION 2. Section 302A-624, Hawaii Revised Statutes, is

20		department.

- 4 (d) In case of promotion from a teaching position to an
- 5 educational officer, the employee shall receive compensation at
- 6 the lowest step of the higher grade that exceeds the employee's
- 7 existing compensation by at least eight per cent if such a step

- 9 (e) Effective July 1, 2006, the minimum hourly or minimum
- 10 per diem rate for substitute teachers shall be determined by the

3	(f) Effective July 1, 2008, the board of education shall		
4	provide wage adjustments for substitute teachers. The wage		
5	adjustments shall be comparable to the across-the-board per cent		
6	wage adjustments for teachers that are negotiated with		
7	collective bargaining unit 5. The board may also adjust hours,		
8	benefits, and other terms and conditions of employment for		
9	substitute teachers."		
10	SECTION 3. There is appropriated out of the general		
11	revenues of the State of Hawaii the sum of \$2,000,000 or so much		
12	thereof as may be necessary for fiscal year 2008-2009 for		
13	retroactive across-the-board pay increases to substitute		
14	teachers for the 2007-2008 school year and for negotiated		
15	across-the-board pay increases for the 2008-2009 school year.		
16	The sum appropriated shall be expended by the department of		
17	education for the purposes of this Act.		
18	SECTION 4. Statutory material to be repealed is bracketed		
19	and stricken. New statutory material is underscored.		

SECTION 5. This Act shall take effect on July 1, 2008.

Substitute Teachers; Wages

### Description:
