A BILL FOR AN ACT

RELATING TO LEGAL SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the board of		
2	education is faced with increasingly complex legal issues and		
3	matters that require expedited attention and legal response.		
4	Having the flexibility to hire independent legal counsel will		
5	expedite the disposition of legal issues and cases related to		
6	the board's purview and the public schools and public libraries		
7	The purpose of this Act is to authorize the board of		
8	education to employ or retain its own attorneys.		
9	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is		
10	amended by adding a new section to be appropriately designated		
11	and to read as follows:		
12	"§302A- Board attorneys. (a) The board may appoint or		
13	retain by contract one or more attorneys who are independent of		
14	the attorney general, to provide legal services for the board,		
15	including:		
16	(1) Representation for the board in civil actions to which		
17	the board is a party, either directly or through the		
18	acts or omissions of its members or employees;		

1	(2)	Advice and assistance to ensure the lawful and	
2		efficient administration and operation of the board;	
3		and	
4	(3)	Other legal services specified by the board.	
5	The board	may establish the compensation of the attorneys	
6	appointed	pursuant to this section. Attorneys appointed or	
7	retained b	by contract shall be exempt from chapters 76 and 89.	
8	(b)	Nothing in this section precludes the board from	
9	requesting	g and securing legal services from the attorney general	
10	and the department of the attorney general for the board or its		
11	members, upon mutual agreement."
