BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 184-3.4, Hawaii Revised Statutes, is 2 amended to read as follows:

3 "§184-3.4 State parks special fund. (a) There is

4 established within the state treasury a fund to be known as the

5 state parks special fund, into which shall be deposited:

- (1) All proceeds collected by the state parks programs involving park user fees, any leases or concession agreements, the sale of any article purchased from the department to benefit the state parks programs, or any gifts or contributions; provided that proceeds derived from the operation of Iolani Palace shall be used to supplement its educational and interpretive programs; and
- (2) Transient accommodations tax revenues pursuant to section 237D-6.5; provided that these moneys shall be expended in response to a master plan developed in coordination with the Hawaii tourism authority.

1	(b) The	department shall expend the moneys from the state
2	parks special	fund for the following purposes:
3	(1) Per	manent and temporary staff positions;
4	(2) Pla	nning and development of state parks programs,
5	inc	luding the aina hoomalu state parks program;
6	(3) Con	struction, repairs, replacement, additions, and
7	exte	ensions of state parks facilities;
8	(4) Ope	ration and maintenance costs of state parks and
9	sta	te parks programs; and
10	(5) Adm	inistrative costs of the division of state parks.
11	(c) The	re is established within the state parks special
12	fund, a Diamond Head State Monument sub-account, into which	
13	shall be depos	sited fifty-five per cent of all proceeds collected
14	from the admission fees charged at the Diamond Head State	
15	Monument. The department shall expend the moneys from the	
16	Diamond Head State Monument sub-account for repair, maintenance,	
17	and operating costs incurred by the State in the management of	
18	the Diamond Head State Monument.	
19	(d) The	re is established within the state parks special
20	fund, a Kokee state park and Waimea Canyon state park	
21	sub-account, into which shall be deposited per cent of all	
22	proceeds colle	ected from concessions, leases, and commissions, as

- 1 well as other user fees charged at or for Kokee state park or
- 2 Waimea Canyon state park, less any net amounts due to the office
- 3 of Hawaiian affairs. The department shall expend the moneys
- 4 from the Kokee state park and Waimea Canyon state park
- 5 sub-account for repair, maintenance, and operating costs
- 6 incurred by the State in the management of Kokee state park and
- 7 Waimea Canyon state park."
- 8 SECTION 2. New statutory material is underscored.
- 9 SECTION 3. This Act shall take effect on July 1, 2020.
