A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR A HEALTH CENTER IN PUNA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Puna is a very rural
- 2 place with few paved roads, and many places with no electricity,
- 3 running water, or telephone service. The Pahoa Family Health
- 4 Center is the only medical provider in the district of Puna,
- 5 located 20 miles southwest of Hilo in an area twice the size of
- 6 Oahu, but with a population of only 30,000 residents, making
- 7 access to health care a serious matter for the hard working
- 8 people of this district.
- 9 A comprehensive health center for the people of Puna built
- 10 through a cooperative effort with the department of Hawaiian
- 11 home lands and to be called "Kahi 'Olu'olu O Maku'u," a place of
- 12 comfort, would ensure access to quality health care services.
- 13 This facility will be a pu'uhonua or "place of refuge" that will
- 14 focus on six components of health services, including:
- 15 (1) Traditional medicine;
- 16 (2) Health and wellness programs;
- 17 (3) Veterans health services;
