A BILL FOR AN ACT

RELATING TO PARENTAL RESPONSIBILITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Damages, injury, or death caused by student; 5 reward; parent or guardian liable. (a) The parent or guardian 6 of any minor whose wilful misconduct results in injury or death 7 to any minor student or any person employed by, or performing 8 volunteer services for, a school or who wilfully cuts, defaces, 9 or otherwise injures in any way any property, real or personal, 10 belonging to a school, or personal property of any school 11 employee, shall be liable for all damages so caused by the minor 12 student. The liability of the parent or guardian shall not 13 exceed \$10,000. The parent or quardian shall also be liable for 14 the amount of any reward not exceeding \$10,000 paid to identify 15 the minor student. The parent or guardian of a student shall be 16 liable to a school for all property belonging to the school
