A BILL FOR AN ACT

RELATING TO FRAUD PREVENTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that every notary public must keep an engraved seal of office or a rubber stamp facsimile 2 seal that clearly shows, when embossed, stamped, or impressed 3 upon a document, the notary's name and the words, "notary 4 public" and "State of Hawaii." The notary public must 5 6 authenticate all the notary's official acts, attestations, certificates, and instruments and always add to an official 7 8 signature the typed or printed name of the notary and a 9 statement showing the date that the notary's commission expires. 10 The legislature also finds that each time a notary public notarizes a document, the notary public must record the type, 11 date, and time of day of the notarial act, the title or type and 12 date of the document or proceeding, the signature, printed name, 13 14 and address of each person whose signature is notarized and of 15 each witness, other parties to the instrument, and the manner in which the signer was identified. All copies or certificates 16

granted by the notary must be under the notary's hand and

- 1 notarial seal and shall be received as evidence of such
- 2 transactions.
- 3 The legislature further finds that, notwithstanding the
- 4 requirements that attend notarization of documents, there is an
- 5 alarming increase in the alteration of notarized documents for
- 6 the purpose of identity theft and fraud. For example, a Hawaii
- 7 man with a federal criminal record involving bank fraud, bogus
- 8 names, and false checks was recently convicted of identity theft
- 9 and other offenses arising from the use of a notarized document
- 10 relating to the sale of an automobile to transfer land and
- 11 property.
- 12 The purpose of this Act is to ensure that notarized
- 13 documents can not be altered by substituting material that does
- 14 not relate to the document to which the notarial seal originally
- 15 was applied.
- 16 SECTION 2. Section 456-3, Hawaii Revised Statutes, is
- 17 amended to read as follows:
- 18 "§456-3 Seal[+]; placement. (a) Every notary public
- 19 shall constantly keep an engraved seal of office or a rubber
- 20 stamp facsimile seal [which] that shall clearly show, when
- 21 embossed, stamped, or impressed upon a document, the notary's
- 22 name, and the words[+] "notary public" and "State of Hawaii".

1 The notary public shall authenticate all the notary's official 2 acts, attestations, certificates, and instruments therewith $[\tau]$ and shall always add to an official signature the typed or 3 printed name of the notary and a statement showing the date that 4 5 the notary's commission expires. The notary public shall emboss, stamp, or impress the notary's seal over a succinct 6 7 phrase describing the document. 8 (b) Upon resignation, death, expiration of term of office 9 without reappointment, or removal from or abandonment of office, 10 [the notary public shall immediately deliver] the notary's seal 11 shall immediately be delivered to the attorney general who shall deface or destroy the same. If any notary fails to comply with 12 13 this section within ninety days of the date of the notary's 14 resignation, expiration of term of office without reappointment, or removal from or abandonment of office or if the notary's 15 personal representative fails to comply with this section within 16 ninety days of the notary's death, then the notary public or the 17 18 notary's personal representative shall forfeit to the State not more than \$200, in the discretion of the court, to be recovered 19 20 in an action to be brought by the attorney general on behalf of

the State."
