A BILL FOR AN ACT

RELATING TO A TECHNOLOGY MASTER PLAN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. In 1983, the legislature created the high
- 2 technology development corporation as a means to facilitate
- 3 growth in the high technology industry. Since then, various
- 4 measures promoting the continuation of the high technology
- 5 industry have been enacted.
- 6 In 1990, the legislature established the Hawaii strategic
- 7 development corporation to encourage development and
- 8 diversification by stimulating the investment of private capital
- 9 in the State. Act 221, Session Laws of Hawaii 2001, supported
- 10 the establishment of high technology companies in Hawaii by
- 11 expanding the application of the high technology business
- 12 investment tax credit. Further, Act 215, Session Laws of Hawaii
- 13 2004, complemented Act 221, by creating the state private
- 14 investment fund, which fills the current funding gap for later-
- 15 stage Hawaii companies by creating a diversified investment fund
- 16 secured by the State.
- 17 Positive growth in high technology companies and continued
- 18 growth in the State's economy indicate that efforts to stimulate



- 1 the high technology industry by providing venture capital have
- 2 been worthwhile. Hawaii has experienced an influx of high
- 3 technology companies over the past five years, and many of these
- 4 companies are beginning to enter the profitability stage of
- 5 their growth. A rising demand for increased incentives and
- 6 further support from the State mandates the establishment of
- 7 concrete plans and a unified vision for the future of Hawaii's
- 8 high technology sector.
- 9 The legislature finds that a task force focusing on
- 10 defining the direction of Hawaii's high technology industry is
- 11 the necessary next step in the process of continued growth. The
- 12 purpose of this Act is to establish the high technology industry
- 13 task force for the State. The primary responsibility of the
- 14 task force will be to develop a state master plan for high
- 15 technology.
- 16 SECTION 2. (a) The high technology industry task force is
- 17 established within the high technology development corporation.
- 18 The high technology development corporation and, if necessary,
- 19 the department of business, economic development, and tourism
- 20 shall provide all necessary administrative and staff support for
- 21 the task force.



1	(b)	The governor shall encourage members of the community	
2	to nomina	te persons for the task force. All members shall serve	
3	at the pl	easure of the governor, who shall select the	
4	chairperson from among the members. The task force shall		
5	consist of eighteen members to be appointed by the governor and		
6	shall include:		
7	(1)	Three members to be nominated by the president of the	
8		senate;	
9	(2)	Three members to be nominated by the speaker of the	
10		house of representatives;	
11	(3)	The president of the University of Hawaii or designee;	
12	(4)	The chairperson of the board of education or designee;	
13	(5)	Senior-level private sector business leaders,	
14		representing Hawaii's traditional primary industries,	
15		such as visitor, construction, defense, and property	
16		development;	
17	(6)	Senior-level business leaders from Hawaii's emerging	
18		innovation sectors, such as biotechnology and	
19		healthcare, dual-use, ocean and earth sciences,	
20		astronomy and optics, agriculture, and film and	
21		creative media;	

1	(7)	Members representing professional services sectors,
2		such as finance, venture capital, accounting, and
3		marketing; and
4	(8)	Cultural and natural resources leaders representing
5		the diversity of ethnic heritages and cultural
6		understandings within Hawaii.
7	(c)	Members of the task force shall serve without pay, but
8	may be re	imbursed for necessary expenses, including travel
9	expenses	incurred in the performance of official duties if funds
10	are avail	able.
11	(d)	The task force shall meet at least quarterly or more
12	frequentl	y at the discretion of the chairperson.
13	(e)	The primary tasks of the task force shall include:
14	(1)	Evaluating the effectiveness of past and current high
15		technology legislation, including Act 215, Session
16		Laws of Hawaii 2004;
17	(2)	Developing a master plan for the direction of high
18		technology in Hawaii, which shall include:
19		(A) A list of goals established for the high
20		technology sector in the State;
21		(B) A plan to reach the established goals; and
22		(C) A timeline for implementation and completion;

1	(3)	Assisting the legislature in maintaining an overall	
2		framework to guide the development of high technology	
3		in the State by creating guidelines for future high	
4		technology legislation; and	
5	(4)	Submitting recommendations for high technology	
6		legislation to meet the goals established in the high	
7		technology master plan.	
8	(f)	The task force shall submit the master plan and a	
9	report, i	ncluding necessary proposed legislation, to the	
10	legislature and the governor no later than twenty days prior to		
11	the convening of regular session of 2010 and shall issue an		
12	updated report every two years thereafter that reassesses the		
13	master plan.		
14	(g)	After the regular session of 2010, the terms of the	
15	task forc	e members shall end and the governor shall appoint	
16	eight mem	bers and the president of the senate and the speaker of	
17	the house	of representatives shall each nominate eight members	
18	to be appointed by the governor.		
19	SECT	ION 3. There is appropriated out of the general	
20	revenues	of the State of Hawaii the sum of \$ or so much	

thereof as may be necessary for fiscal year 2008-2009 for the

task force to carry out the purposes of this Act.
