1	(2) Payment of the reward shall be made no later than
2	thirty days after restitution sufficient to cover the

5	(c) The department may contract with a third party for

7	(d) The department may establish rules pursuant to chapter
8	91 for purposes of this section.
9	§346-B Special account; creation; disbursements. (a) The
10	department may establish a special account for purposes of

12	(b) Restitution or a portion thereof received by the
13	department as a result of fraud committed under section 346-34
14	or 346-43.5 may be deposited into the special account. The
15	moneys deposited into the special account including interest

1 "(b) If, at any time while the recipient of public assistance is receiving public assistance, the recipient's 2 living requirements are reduced and the recipient wilfully fails 3 4 to report the reduction within thirty days from the date of the reduction to the department, or the recipient acquires from any 5 source real property, funds, income, or other resources and 6 wilfully fails to report the amount acquired together with the 7 8 source of the resources to the department within thirty days of 9 receipt of the resources, or prior to spending or otherwise 10 disposing of all or any portion of the resources, the recipient 11 shall be guilty of a [petty misdemeanor.] misdemeanor." 12 SECTION 3. Department of Human Services Assistance; Fraud Reward Program

Description:

Establishes a reward program for reporting of fraudulent claims made to Department of Human Services (DHS) assistance programs. Increases penalty for committing fraud under assistance programs from a petty misdemeanor to a misdemeanor. Allows DHS to create a special account and contract for payment of rewards. (HB2935 HD1)
