### A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Findings and purpose. The legislature finds 2 that with in-migration and the aging of our population, among other things, the demographics of the State are evolving. Over 3 4 the past twenty-five years, the statewide population has increasingly shifted from the urban core to the suburbs, 5 6 especially on Oahu, where the population center has steadily 7 moved to the western side of the island. Meanwhile, some of the 8 areas in the State with the fastest-growing populations are 9 Kihei, Maui, and west Hawaii. These demographic shifts have 10 overburdened public school facilities in growing areas and left some public school facilities in other areas underutilized. 11 12 Thus, the legislature believes there is a need to revitalize school facilities statewide, including building or expanding 13 schools in certain areas and consolidating or closing schools in 14 15 other areas.
- However, the legislature finds that despite broad-based
  public recognition of Hawaii's changing demographics, there is
  often little public support for changes that affect specific

constituencies. In particular, this is true of proposals to

    close or consolidate public schools to maximize resources.

         The legislature recognizes the difficulties, political and
    otherwise, inherent in these decisions. But in the face of
4

    increasing educational priorities, the legislature believes that
    just as the construction or expansion of some schools is
6
7
    important, the consolidation or closure of other schools is also
    necessary. It is important that any actions to do so be taken
8

    through a very objective and transparent process that benefits
    the greatest number of public school students and their
10

    families.

         The purpose of this Act is to revitalize school facilities
13
    statewide and to more effectively and efficiently use our
14
    taxpayers' investment in public education. Specifically, this
    Act provides for the timely construction, expansion,
15
    consolidation, or closure of underutilized public schools in

5	(2)	Directs the board of education to proceed with the
6		process of constructing, expanding, consolidating, or
7		closing underutilized schools according to the
8		recommendations of the facilities alignment
9		commission.
10	SECT	ION 2. Facilities alignment commission. (a) There is
11	establish	ed the facilities alignment commission, to be attached
12	to the dep	partment of education for administrative purposes. The
13	commission	n shall be composed of nine members appointed by the
14	governor;	provided that:
15	(1)	Three members shall be appointed from a list of
16		nominees submitted by the president of the senate, of
17		which two shall be persons with professional
18		experience in education, including former or current
19		teachers or administrators; and
20	(2)	Three members shall be appointed from a list of
21		nominees submitted by the speaker of the house of
22		representatives, of which two shall be persons with

- professional experience in education, including former
- or current teachers or administrators.
- 3 (b) The chairperson of the commission shall be selected by
- 4 the members of the commission.
- 5 (c) A majority of the commission's membership shall be
- 6 comprised of persons with professional experience in education,
- 7 including current or former teachers or administrators.
- **8** (d) At least one member shall be a representative of the
- 9 department of education.
- (e) With the sole exception of those who are education
- 11 professionals, members of the commission shall not be employees
- 12 of the State.
- (f) Any substantive action taken by the commission
- 14 pursuant to sections 4 through 6 of this Act shall be approved
- 15 by a two-thirds vote of its members. For all other actions of
- 16 the commission, five members shall constitute a quorum to do
- 17 business, of which a majority vote shall suffice.
- 18 (g) The commission shall be exempt from chapter 91, Hawaii
- 19 Revised Statutes, but shall be subject to chapters 92 and 92F,
- 20 Hawaii Revised Statutes.

1 The members of the commission shall serve without (h) 2 compensation but shall be reimbursed for expenses necessary for 3 the performance of their duties, including travel expenses. 4 (i) The department of education shall provide 5 administrative support to the commission. The commission shall 6 have access to all records in the department of education and 7 department of accounting and general services pertinent to its 8 duties and may request research and analysis assistance from the 9 department of education. Pursuant to chapter 92F, Hawaii 10 Revised Statutes, the commission shall maintain the 11 confidentiality of all confidential information. The commission shall terminate upon adjournment of the 12 13 regular legislative session of 2010, sine die. 14 SECTION 3. Procedures for making recommendations for 15 school alignment; school facilities plan. (a) The department 16 of education shall submit to the commission by August 31, 2008, 17 a thirty-year school facilities plan. The school facilities plan shall be based on the department's assessment of the 18 19 projected student enrollment for every public school in the 20 State, other than for charter schools. In conducting the

assessment, the department shall:

1	(1)	Consider the six-year program and financial plan
2		prepared pursuant to section 37-69, Hawaii Revised
3		Statutes, to the extent it is applicable;
4	(2)	Develop and consider a thirty-year projection of the
5		enrollment at each school across the State and the
6		resulting need for facilities; and
7	(3)	Consider other reliable data relative to population
8		growth and trends, and anticipated levels of funding
9		necessary for every school.
10	(b)	The school facilities plan shall include:
11	(1)	A description of the assessment of projected student
12		enrollment pursuant to subsection (a);
13	(2)	A comprehensive inventory of all department of
14		education facilities;
15	(3)	For each school district, thirty-year projections for
16		the numbers and locations of schools required annually
17		to accommodate the numbers and types of students in
18		the projected enrollment; and
19	(4)	Recommendations for the construction, expansion,
20		consolidation, or closure of underutilized schools
21		based on the projections and assessment made pursuant
22		to this section.

1	SECT	ION 4. School alignment selection criteria. (a) By
2	December 3	31, 2008, the commission shall establish the criteria
3	that will	be used by the commission to select:
4	(1)	Areas for new school construction;
5	(2)	Schools for expansion, other than charter schools;
6	(3)	Schools to be consolidated, other than charter
7		schools; and
8	(4)	Underutilized schools to be closed, other than charter
9		schools.
10	(b)	The criteria shall require the consideration of:
11	(1)	The overutilization or underutilization of school
12		facilities;
13	(2)	The academic and extracurricular achievement or
14		successes of the student body, and whether that
15		success was due at least in part to the existing size
16		of the school;
17	(3)	The best interests of the students and preserving
18		their potential for success;
19	(4)	The impact of the consolidation or closure of a school
20		on the community in which it is located; and
21	(5)	The costs or savings resulting from the continued
22		operation, consolidation, or closure of a school,

              including the costs of deferred and future repair and

              maintenance.

    criteria, the commission shall hold public hearings to obtain

    public response to the commission's proposed criteria. For each

         SECTION 5. Preliminary recommendations. (a) By
13
    February 28, 2009, based on the school facilities plan developed
14
    pursuant to section 3 and the final school alignment selection
15
    criteria adopted pursuant to section 4, the commission shall

    compile a preliminary list of recommended:

- 1 (b) The list of recommendations shall include a summary of
- 2 the selection process that resulted in the recommendation of
- 3 each area or school on the list, including a justification for
- 4 each recommendation.
- 5 (c) In selecting areas and schools for the list, the
- 6 commission shall consider equally all schools within the State,
- 7 without regard to whether the board of education had previously
- 8 considered the school for consolidation or closure.
- 9 SECTION 6. Public hearings and final recommendations by
- 10 the commission. (a) By August 31, 2009, the commission shall
- 11 hold public hearings to obtain public response to the
- 12 commission's preliminary recommendations. For each public
- 13 hearing, the commission shall provide appropriate notice as
- 14 defined in section 1-28.5, Hawaii Revised Statutes, both
- 15 statewide and county-wide in each county of the State. The
- 16 commission shall make available to the public draft copies of
- 17 the preliminary recommendations not less than two weeks prior to
- 18 the start of the public hearings.
- (b) Not less than twenty days prior to the convening of
- 20 the regular session of 2010, the commission shall submit to the
- 21 legislature a report of its findings and conclusions, including
- 22 a final list of recommendations for:



1 Areas for new school construction: (1)(2) Schools for expansion, other than charter schools; 2 Schools to be consolidated, other than charter 3 (3)4 schools; and Underutilized schools to be closed, other than charter 5 (4)6 schools. 7 The final list of recommendations shall be subject to legislative disapproval only in its entirety, by concurrent 8 9 resolution. 10 (d) If the legislature does not disapprove the recommendations pursuant to subsection (c), then after the 11 12 adjournment of the regular legislative session of 2010, sine 13 die, the board of education shall begin implementing the 14 recommendations of the commission for the 2011-2012 school year 15 to: Construct new schools; 16 (1)17 Expand schools; and (2) Consolidate or close underutilized schools. 18 (3)19 SECTION 7. There is appropriated out of the general 20 revenues of the State of Hawaii the sum of \$ or so

much thereof as may be necessary for fiscal year 2008-2009 for

- 1 expenses incurred by the facilities alignment commission in
- 2 carrying out its duties.
- 3 The sum appropriated shall be expended by the department of
- 4 education for the purposes of this Act.
- 5 SECTION 8. This Act shall take effect on July 1, 2008.

#### Report Title:

School Facilities; Facilities Alignment Commission

#### Description:

Creates the facilities alignment commission to revitalize school facilities by developing and submitting recommendations for areas for new school construction, schools for expansion, and schools for consolidation or closure. Allows the legislature to disapprove these recommendations only in their entirety. If no legislative disapproval occurs, requires the Board of Education to comply with these recommendations.
