## A BILL FOR AN ACT

RELATING TO PROSTITUTION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 712-1200, Hawaii Revised Statutes, is 2 amended by amending subsections (3) and (4) to read as follows:

3 "(3) Prostitution is a petty misdemeanor [-], except as

4 provided in subsection (4).

(4) A person convicted of committing the offense of prostitution shall be sentenced as follows:

- 7 For [the] a first offense, when the court has not (a) 8 deferred further proceedings pursuant to chapter 853, 9 a mandatory fine of \$500 and the person may be sentenced to a term of imprisonment of not more than 10 11 thirty days or probation; provided that in the event 12 the convicted person defaults in payment of the \$500 13 fine, and the default was not contumacious, the court 14 may sentence the person to perform services for the community as authorized by section 706-605(1). 15
- (b) For [any] a subsequent offense, a mandatory fine of \$500 and a term of imprisonment of thirty days or probation, without possibility of deferral of further
