RELATING TO MOTOR VEHICLE REGISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 291E-48, Hawaii Revised Statutes, is		
2	amended to read as follows:		
3	"[+] §291E-48[+] Special motor vehicle registration. (a)		
4	Anytime after the effective date of revocation or after the		
5	administrative hearing decision is mailed pursuant to section		
6	291E-38(j), a qualified household member or co-owner of a motor		
7	vehicle with a respondent who has had a motor vehicle		
8	registration revoked under this part may submit a sworn		
9	statement to the director requesting a special motor vehicle		
10	registration. The director may grant the request upon		
11	determining that the following conditions have been met:		
12	(1) The applicant is a household member of the		
13	respondent's or a co-owner of the vehicle;		
14	(2) The applicant has a license that has not expired or		
15	been suspended or revoked;		
16	(3) The applicant is [completely] dependent on the motor		
17	vehicle for the necessities of life; and

1	(4)	The director finds that the applicant will take
2		reasonable precautions to ensure that the respondent
3		will not drive the vehicle.

- 4 The director shall also consider the impact, including
- 5 adverse effects, of refusing to grant the special motor vehicle
- 6 registration on the respondent's household members.
- 7 A person to whom a special motor vehicle registration has
- 8 been granted shall apply to the appropriate county director of
- 9 finance for special series number plates, as provided in section
- 10 249-9.4.
- 11 (b) The director shall revoke the special motor vehicle
- 12 registration if any one of the conditions set forth in the
- 13 application no longer exist.
- 14 (c) The applicant shall be under an affirmative duty to
- 15 report to the director any changes in the conditions to the
- 16 special motor vehicle registration.
- 17 (d) The director shall adopt rules, pursuant to
- 18 chapter 91, necessary to carry out the purposes of this
- 19 section."
- 20 SECTION 2. This Act does not affect rights and duties that
- 21 matured, penalties that were incurred, and proceedings that were
- 22 begun, before its effective date.
