BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 104-2.5, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "[+]\$104-2.5[+] Public work requirements; private 4 construction contracts. (a) Section 104-2 notwithstanding, for 5 purposes of this chapter, public work shall also include a 6 construction contract between private persons if more than fifty 7 per cent of the assignable square feet of a project is leased or 8 assigned for use by the State, any county, or any agency of the 9 State or any county, whether or not the property is privately 10 owned, and: 11 The lease or other agreement is entered into prior to the construction contract becoming effective; or 12 13 Construction work is performed according to a plan, (2) 14 specifications, or criteria established by the State, 15 any county, or any agency of the State or any county. 16 Prior to the start of construction on a project, the (b)
- 17 construction project owner shall sign a lease or other agreement

- 1 with the governmental leasing agency or the governmental agency
- 2 accepting the construction project for its use to certify the
- 3 construction project owner's compliance with this chapter,
- 4 including payment of prevailing wages.
- 5 (c) Copies of the lease or other agreement under
- 6 subsection (b) shall be filed with the department and the
- 7 department of accounting and general services. The construction
- 8 project owner shall submit weekly certified payrolls to the
- 9 governmental leasing agency or the governmental agency accepting
- 10 the construction project for its use, which shall be the
- 11 governmental contracting agency for the construction project.
- 12 (d) Public work shall also include a construction contract
- 13 between private persons using state or county land for
- 14 commercial, profit making activity. The requirement shall be
- 15 included in the lease or other agreement for the use of the
- 16 state or county land. Copies of the lease or other agreement
