RELATING TO TAXATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 235, Hawaii Revised Statutes, is

12	(b) The tax credit shall apply to taxpayers who are

14	(1) Licensed adult residential care homes under sections		
15	321-15.6 and 321-15.62, both types I and II;

         (c) The tax credit for a taxpayer, including a husband and

    Failure to properly and timely claim the credit shall constitute

## Description:
