A BILL FOR AN ACT

RELATING TO THE HAWAII HIGHER EDUCATION COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that as Hawaii's technology sector grows, and as technology becomes embedded in many of our more traditional industries, there is a growing need 3 for a workforce that has basic science, technology, engineering and mathematical skills, as well as graduates with specialized science and engineering degrees. Some states are addressing 6 their science, technology, engineering, and math education, as 7 well as other strategic post-secondary education needs through a 8 strong commission on higher education. Examples include New Jersey, California, Arizona, and Maryland, among others. 10 these states, the commission helps coordinate an integrated 11 system of higher education that includes both public and private 12 13 institutions. Common goals of these commissions include: increasing the 14 rate of students pursuing post-secondary education; improving 15 access to education, training, and lifelong learning; engaging 16 17 the business community in setting goals and objectives; and

- 1 changing public perceptions and aspirations regarding higher
- 2 education.
- 3 In Hawaii, the state post-secondary education commission,
- 4 established by section 304A-3151, Hawaii Revised Statutes, has a
- 5 limited scope. Its legislative mandate is primarily to serve as
- 6 a vehicle for receiving federal funds and there is a brief
- 7 section authorizing the commission to develop procedures for
- 8 receiving and responding to complaints. Most of the seats are
- 9 assigned to representatives of the University of Hawaii,
- 10 including all of the board of regents, and the commission is
- 11 placed administratively in the University of Hawaii, with the
- 12 university president designated as the administrative officer of
- 13 the commission.
- 14 The legislature further finds that a state post-secondary
- 15 education commission with broader representation and a more
- 16 comprehensive mandate would better serve the State's needs
- 17 relative to meeting the challenges of a global economy. A
- 18 commission with representatives from all public and private
- 19 institutions of higher education, government, business, and the
- 20 general public could develop a vision and a strategy to move
- 21 Hawaii toward excellence in the twenty-first century.

The purpose of this Act is to amend chapter 304A, Hawaii 1 2 Revised Statutes, to broaden the representation on the state post-secondary education commission and expand its mission. SECTION 2. Chapter 304A, Hawaii Revised Statutes, is 4 5 amended by amending the title of subpart C of part VII to read as follows: 6 "C. [STATE POST-SECONDARY] HAWAII HIGHER EDUCATION 7 COMMISSION" SECTION 3. Section 304A-3151, Hawaii Revised Statutes, is amended to read as follows: 10 "[+]\$304A-3151[+] Establishment of the [state post-11 secondary | Hawaii higher education commission; membership, 12 13 administration. There is established a state [post-secondary education] commission[-] on higher education to be known as the 14 Hawaii higher education commission. The commission shall 15 consist of [the members of the board of regents of the 16 university, the provisions of section 78-4 notwithstanding, and 17 four other members who shall be broadly and equitably 18 representative of the general public and public and private 19 nonprofit and proprietary institutions of post-secondary 20 21 education in the State who shall be appointed] no more than

nineteen members to be appointed by the governor in accordance

with section 26-34[-] to include the following, the provisions 1 of section 78-4 notwithstanding: 3 (1)The president of the University of Hawaii; (2)The president of Brigham Young University-Hawaii; 4 The president of Chaminade University; (3) The president of Hawaii Pacific University; (4)6 7 (5) The superintendent of education; The executive director of the Hawaii Association of 8 (6) Independent Schools; 9 The director of business, economic development, and 10 (7^{\cdot}) 11 tourism; The director of labor and industrial relations; (8) 12 The chair of the governor's innovation council; (9)13 Four members of Hawaii's business community, from 14 (10)15 different economic sectors; Four members of the general public, one from each 16 (11)17 county; and Two university students, to serve terms of one year, 18 (12)to be nominated by the student governing body of their 19 respective institutions. 20 The chair of the commission shall initially be appointed by the 21 governor for a term of one year, following which the chair shall 22

- 1 be elected by the members of the commission. The commission
- 2 shall be placed within the University of Hawaii for
- 3 administrative purposes [and its administrative officer shall
- 4 be the president of the university]. The commission may appoint
- 5 necessary staff members to carry out its mandate in accordance
- 6 with applicable policies and procedures of the university [-],
- 7 and as provided for in the state budget."
- 8 SECTION 4. Section 304A-3152, Hawaii Revised Statutes, is
- 9 amended to read as follows:
- "[+]\$304A-3152[+] Commission's powers and authority. (a)
- 11 The commission may cooperate with the federal government to
- 12 qualify the State to receive federal funds made available under
- 13 the Higher Education Act of 1965, Public Law 89-329, as amended
- 14 from time to time, and in addition may serve as the state agency
- 15 for the receipt of federal funds when federal legislation
- 16 dealing with higher education or post-secondary education
- 17 requires, as a condition of state receipt of such funds, the
- 18 designation of a state agency that is broadly representative of
- 19 the general public and of post-secondary education in the State
- 20 and when agencies other than the commission created by this
- 21 subpart may not qualify. The commission also may receive funds
- 22 from other sources to carry out its mandate. The commission

- 1 shall adopt appropriate rules not inconsistent with this subpart
- 2 as may be required to administer this subpart. The rules shall
- 3 be adopted in accordance with chapter 91.
- 4 (b) No funds appropriated by the legislature may be used
- 5 to aid a person attending an institution not owned or
- 6 exclusively controlled by the State or a department of the State
- 7 or to pay for any staff work distributing federal or private
- 8 funds to students attending such schools. The maximum amount of
- 9 any grant awarded under the Hawaii state incentive grant program
- 10 shall be equal to the maximum allowed by federal law.
- 11 (c) The commission shall propose and manage a program to
- 12 provide incentives, such as scholarships, grants, and loans,
- 13 including specific programs designed to meet workforce needs,
- 14 such as science, technology, engineering, and math scholarships
- 15 or loan forgiveness plans.
- 16 (d) The commission shall have the authority to evaluate
- 17 Hawaii's elementary and secondary public schools, including
- 18 their ability to prepare Hawaii's students for post-secondary
- 19 education.
- 20 (e) The commission shall have the authority to review and
- 21 recommend policies that increase the rate of students pursuing
- 22 post-secondary education."

2	amended to read as follows:
3	"[+]§304A-3154[+] Cooperation with other state agencies.
4	The commission may be assisted by other state agencies,
5	including but not limited to the University[$_{7}$] of Hawaii, the
6	department of education, [and] the department of commerce and
7	consumer affairs[-], the department of business, economic
8	development, and tourism, and the department of labor and
9	industrial relations."
10	SECTION 6. Statutory material to be repealed is bracketed
11	and stricken. New statutory material is underscored.
12	SECTION 7. This Act shall take effect on July 1, 2008.
13	The commission members serving on June 30, 2008 shall continue
14	their duties until the new commission as constituted by this Act
15	is appointed.

TITLE:

PURPOSE:

To improve the quality of higher education in Hawaii through the renaming of the state post-secondary education commission to the Hawaii higher education commission, broadening the membership, and expanding the powers and authority of the commission to provide an integrated approach to higher education in the State that will more aggressively help the State meet the needs

of a 21st century economy.

MEANS:

Amend the title of subpart C of part VII of chapter 304A and sections 304A-3151, 304A-3152, and 304A-3154, Hawaii Revised Statutes.

JUSTIFICATION:

As Hawaii's technology sector grows, and as technology becomes embedded in many of our more traditional industries, there is a growing need for a workforce that has basic science, technology, engineering and mathematical (STEM) skills, as well as graduates with specialized STEM degrees. The concept of a pipeline to produce a STEMliterate population was at the core of the Innovation in Education proposals submitted to the 2007 Legislature. The science and technology academies are designed to spark interest and build competence. To complete the commitment to produce a qualified workforce for emerging technology jobs, more STEM college graduates will be needed.

Several states are addressing their STEM education, as well as other strategic post secondary education needs, through a strong Commission on Higher Education. In Hawaii, the State Post-Secondary Education Commission, established by section 304A-



3151, has a very limited scope. Its legislative mandate is primarily to serve as a vehicle for receiving federal funds and there is a brief section authorizing the Commission to develop procedures for receiving and responding to complaints. The Commission is placed administratively in the University of Hawaii and the UH president is the administrative officer of the Commission.

Impact on the public: The ultimate goal of improving the State's ability to provide a quality STEM education is to raise the skill level of Hawaii's workforce, thereby increasing our ability to compete in a global economy, producing higher incomes and a better standard of living for Hawaii's residents.

Impact on the department and other agencies:
There will be no direct impact on the
department. The University of Hawaii will
be impacted by having their responsibilities
broadened regarding the new higher education
commission and receiving additional
resources to improve their ability respond
to the mandate.
