A BILL FOR AN ACT

RELATING TO CONTRACTOR PENALTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 444-23, Hawaii Revised Statutes, is
 amended to read as follows:

"\$444-23 Violation; penalties. (a) Any licensee who
contracts outside the appropriate scope of classification for
which the licensee is licensed shall be fined [\$500] up to
\$2,500 for the first offense, [\$1,000] up to \$5,000 for the
second offense, and not less than [\$1,500 or more than \$2,000]
\$5,000 and up to \$10,000 for any subsequent offense.

9 (b) Any licensee who violates section 444-9.3 or
10 444-17(17) shall be fined up to \$25,000 or up to the full amount
11 of the contract price for each offense, whichever is greater.

(c) Except as provided in subsections (a), (b), (d), and
(e), any person who violates or fails to comply with this
chapter shall be fined not less than [\$100] \$1,500 or more than
\$5,000 for each violation; provided that any person who violates
section 444-9 shall be fined:

Description:

Increases fines five-fold that may be imposed on contractors for performing work outside of their licensed specialty, unlicensed activity, and other violations relating to contractors.

JUSTIFICATION SHEET

DEPARTMENT: Commerce and Consumer Affairs

TITLE: A BILL FOR AN ACT RELATING TO CONTRACTOR PENALTIES.

PURPOSE: The purpose of this bill is to increase the amount of fines that may be imposed for violations of chapter 444, Hawaii Revised Statutes (HRS).

MEANS: Amend section 444-23, HRS.

JUSTIFICATION: The penalties for violations such as unlicensed activity, and for contractor violations of chapter 444, HRS, have not been revised since 1990. Therefore, increasing the fines to reflect current construction costs is warranted. Increasing the fines may also encourage stricter compliance by licensees as well as unlicensed contractors.

Impact on the public: Consumers may benefit from increased compliance with chapter 444, HRS, by contractors.

Impact on the department and other agencies: The proposed amendments will bolster the department's enforcement efforts.

It is not anticipated that this bill will impact other governmental agencies.
