A BILL FOR AN ACT

PROPOSING AMENDMENTS TO THE CONSTITUTION OF THE STATE OF HAWAII RELATING TO PUBLIC EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to propose		
2	amendments to the state constitution to:		
3	(1) Allow a political subdivision's legislative body to		
4	establish an irrevocable local school district; and		
5	(2) Establish and empower local school boards of education		
6	to implement the statewide educational policies and to		
7	formulate and implement local school district		
8	objectives.		
9	SECTION 2. Article X of the Constitution of the State of		
10	Hawaii is amended by adding two new sections to be designated		
11	and to read as follows:		
12	LOCAL SCHOOL DISTRICTS		
13	Section . Provided that two-thirds of the members of a		
14	political subdivision's legislative body vote affirmatively to		
15	establish a irrevocable local school district, such a district		
16	shall be responsible for the delivery of primary and secondary		
17	public education in that political subdivision. Following

1	action by a political subdivision's legislative body to				
2	establish a local school district, the legislature shall be				
3	responsible in the following year to establish fair and				
4	equitable funding and the division of resources to carry out the				
5	decision of the political subdivision's legislative body.				
6	Section . Each local school district shall be governed by				
7	a seven-member board elected by the voters of the district for				
8	staggered terms. The election of members shall take place in				
9	the next statewide election following the vote of the local				
10	subdivision's legislative body. Each local school board shall				
11	have the power, as provided by law, to formulate policy and to				
12	exercise control over the local school district public school				
13	system through its executive officer, the local school district				
14	superintendent, who shall be appointed by the local school				
15	board; except that the local school board shall have				
16	jurisdiction over the internal organization and management of				
17	the local school district public school system, as provided by				
18	law, and shall exercise its jurisdiction in a manner consistent				
19	with general laws."				
20	SECTION 3. Article XVIII of the Constitution of the State				
21	of Hawaii is amended by adding a new section to be appropriately				
22	designated and to read as follows:				

1	"EFFECTIVE DATE FOR SUPERINTENDENT OF EDUCATION AND ELECTED			
2	LOCAL SCHOOL BOARDS OF EDUCATION			
3	Section . The amendments to Article X Sections 2 and 3			
4	shall take effect following ratification and upon the day the			
5	elected local school boards of education begin functioning as			
6	provided by law."			
7	SECTION 4. Article XVI, section 4, of the Constitution of			
8	the State of Hawaii is amended to read as follows:			
9	"OATH OF OFFICE			
10	Section 4. All eligible public officers, before entering			
11	upon the duties of their respective offices, shall take and			
12	subscribe to the following oath or affirmation: "I do solemnly			
13	swear (or affirm) that I will support and defend the			
14	Constitution of the United States, and the Constitution of the			
15	State of Hawaii, and that I will faithfully discharge my duties			
16	as to <u>the</u> best of my ability." As used in this			
17	section, "eligible public officers" means the governor, the			
18	lieutenant governor, the members of both houses of the			
19	legislature, the members of the <u>State</u> board of education, <u>the</u>			
20	members of local school boards of education, the members of the			
21	national guard, State or county employees who possess police

2	requires the consent of the senate."			
3	SECTION 5. Article X, section 2, of the Constitution of the			
4	State of Hawaii is amended to read as follows:			
5	" <u>STATE</u> BOARD OF EDUCATION			
6	Section 2. There shall be a <u>State</u> board of education			
7	composed of members who shall be elected in a nonpartisan manner			
8	by qualified voters, as provided by law, from two at-large <u>State</u>			
9	school board districts. The first <u>State</u> school board district			
10	shall be comprised of the island of Oahu and all other islands			
11	not specifically enumerated. The second State school board			
12	district shall be comprised of the islands of Hawaii, Maui,			
13	Lanai, Molokai, Kahoolawe, Kauai and Niihau. Each at-large			
14	State school board district shall be divided into departmental			
15	school districts, as may be provided by law. There shall be at			
16	least one member residing in each departmental school district.			
17	The Hawaii State Student Council shall select a public high			
18	school student to serve as a nonvoting member on the board of			
19	education."			
20	SECTION 6 Article X section 3 of the Constitution of the

8	policy fo	r its district, and implement statewide educational		
9	policy at the local level, as provided by law."			
10	SECTION 7. The question to be printed on the ballot shall

13	(1)	The duly elected county councils of each political

15		establish a local school district for the purpose of

21	SECTION 8. New constitutional material is underscored.

DEPARTMENT: Office of the Governor

- TITLE: A BILL FOR AN ACT PROPOSING AMENDMENTS TO THE CONSTITUTION OF THE STATE OF HAWAII RELATING TO PUBLIC EDUCATION
- PURPOSE: To allow a political subdivision's legislative body to establish an irrevocable school district and to empower the locally elected district school boards of education to implement the statewide educational policies and to formulate and implement local district objectives.
- MEANS: Amend the constitution of the State of Hawaii.
- This bill allows voters to decide whether to JUSTIFICATION: grant a political subdivision's legislative body the authority to create an irrevocable local school district. This provides an opportunity for greater input into public education at the local level. The proposed amendment will result in increased participation by local communities in public education, and in the decision making that affects the education of their local students. Decisions will be made by local school boards based on the needs of that community and district, rather than by a central statewide Board of Education that may not take into account the intricacies and special circumstances that define each of the counties in our State.

Impact on the public: Increased involvement in public education at a local level.

Impact on the department and other agencies: The Board of Education, Department of Education, county legislative bodies, local school districts, and local school boards will work to comply with the requirements set forth in the constitution should any Page 2
