A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. Act 56, Session Laws of Hawaii 2007, |

| 2 | established a candidate advisory council for the board of |

| 6 | purposes of this Act are to: |
| 7 | (1) Require the submission of candidates within sixty days |
| 8 | following notification from the governor of a vacancy |
| 9 | due to resignation, death, or removal by the governor; |
| 10 | (2) Require that the council submit the names of |
| 11 | candidates to the governor; |
| 12 | (3) Make confidential all candidate advisory council |
| 13 | information before and after decision-making; and |
| 14 | (4) Require that the candidate reside in the geographic |
| 15 | area they represent. |
| 16 | SECTION 2. Section 26-11, Hawaii Revised Statutes, is |
| 17 | amended by amending subsection (a) to read as follows: |

1 "(a) The University of Hawaii shall be headed by an 2 executive board to be known as the board of regents. The board shall consist of fifteen members. At least one 3 member shall be a University of Hawaii student at the time of 4 5 the initial appointment. This member may be reappointed for one additional term even though the member may no longer be a 6 7 student at the time of reappointment. The governor shall reduce the terms of those initially appointed to each seat on the board 8 9 of regents to provide, as far as practicable, for the expiration of three terms each year; provided that the term of the student 10 member shall not be reduced. 11 At least twelve members, except for the student member, 12 shall represent and reside in the specified geographic areas as 13 follows: 14 Two members from the county of Hawaii; 15 (1)Two members from the county of Maui; (2) 16 17 (3) One member from the county of Kauai; and Seven members from the city and county of Honolulu. 18 (4)19 The board shall have the power, in accordance with the Constitution of the State and with law, to formulate policy and 20 to exercise control over the university through its executive 21

officer, the president of the university. The board shall have

- 1 exclusive jurisdiction over the internal organization and
- 2 management of the university."
- 3 SECTION 3. Section 304A-104.5, Hawaii Revised Statutes is
- 4 amended to read as follows:
- 5 "[+]§304A-104.5[] Candidate] Regents candidate advisory
- 6 council for the board of regents of the University of Hawaii.
- 7 (a) There is established the regents candidate advisory council
- 8 for the board of regents of the University of Hawaii to present
- 9 to the governor pools of qualified candidates from which the
- 10 members of the board of regents shall be nominated and, by and
- 11 with the consent of the senate, appointed by the governor. The
- 12 regents candidate advisory council shall establish the criteria
- 13 for qualifying, screening, and presenting to the governor
- 14 candidates for membership on the board of regents. The regents
- 15 candidate advisory council shall be attached to the University
- 16 of Hawaii for administrative purposes.
- 17 (b) Except as provided in subsection (c), within sixty
- 18 days of convening its first meeting, the regents candidate
- 19 advisory council shall present no fewer than two and no more
- 20 than four qualified candidates to the governor for each vacant
- 21 seat on the board of regents that has arisen due to resignation,
- 22 death, or removal by the governor; provided that for all

- 1 subsequent presentations to the governor, the $\underline{\text{regents}}$ candidate
- 2 advisory council shall present no fewer than two and no more
- 3 than four candidates for each seat on the board of regents to
- 4 the governor within:
- (1) [Thirty] Sixty days following notification from the
 governor of a vacancy that arises by resignation,
 death, or removal by the governor; or
- 8 (2) One hundred twenty days prior to the expiration of a9 term.
- (c) When there are multiple seats vacant within the same

 county or within the at-large membership, the <u>regents</u> candidate

 advisory council shall present candidates for seats on the board

 of regents to the governor as follows:
- 14 (1) For two seats from the same county or two at-large
 15 seats, no fewer than four and no more than six
 16 candidates;
- 17 (2) For three seats from the same county, no fewer than five and no more than eight candidates; and
- (3) For more than three seats, the <u>regents</u> candidate
 advisory council shall determine appropriate minimum
 numbers of candidates, which shall provide for at

One member shall be appointed by the chairperson of 1 (5) the Executive Council of the University of Hawaii 2 Student Caucus; 3 One member shall be appointed by the chairperson of 4 (6) the Association of Emeritus Regents; and 5 (7) One member shall be appointed by the president of the 6 University of Hawaii Alumni Association; 7 provided that members appointed under paragraphs (4) to (7) 8 shall be selected from the general public and may include 9 members of the constituencies represented; provided further that 10 each appointee satisfies the requirements for appointment 11 provided in this subsection, except that individuals who are or 12 have served as members of the executive councils or boards for 13 the organizations under paragraphs (4) and (5) within the last 14 five years immediately preceding the establishment or a vacancy 15 on the regents candidate advisory council for which the persons 16 may be qualified to fill shall not be eligible to serve as 17 members of the regents candidate advisory council. 18 19 The regents candidate advisory council shall be selected in 20 a wholly nonpartisan manner. If any member has not been appointed within one hundred eighty days of [the] May 1, 2007, 21 the sitting members on the regents candidate advisory council 22

- 1 shall make an interim appointment to fill the vacant seat. The
- 2 interim appointee shall satisfy the requirements for appointment
- 3 provided in this subsection and shall serve until the time when
- 4 the appropriate appointing authority makes an appointment for
- 5 the vacant seat as provided in this subsection. Appointees to
- 6 the regents candidate advisory council shall have a general
- 7 understanding of the purposes of higher education, the mission
- 8 of the University of Hawaii system, and the responsibilities of
- 9 the board of regents. Appointees shall be individuals who are
- 10 widely viewed as having placed the broad public interest ahead
- of special interests, having achieved a high level of prominence
- 12 in their respective professions, and being respected members of
- 13 the community.
- 14 (g) Members of the regents candidate advisory council
- 15 shall serve four-year terms; provided that the three members
- 16 initially appointed by the governor, the president of the
- 17 senate, and the speaker of the house of representatives shall
- 18 serve for terms of two years; provided further that terms for
- 19 appointments of the initial members of the regents candidate
- 20 advisory council shall be deemed to begin on July 1, 2007,
- 21 regardless of the actual date of appointment.

- If a vacancy occurs, a successor shall be appointed in 1 the same manner and subject to the same qualifications as the 2 person's predecessor. The person appointed to fill a vacancy 3 shall serve for the remainder of the term of the person's 4 predecessor. 5 (i) The regents candidate advisory council shall operate 6 in a wholly nonpartisan manner. No individual, while a member 7 of the regents candidate advisory council, shall run for or hold 8 any elected office under the United States or the State or any 9 10 of its political subdivisions. The regents candidate advisory council shall convene 11 its first meeting on or after thirty-one days from May 1, 2007;
- 12 provided that, if thirty days after May 1, 2007, all the members 13 14 to which the regents candidate advisory council is entitled have not yet been appointed, the regents candidate advisory council 15 shall convene its first meeting upon the appointment of a 16 majority of its members. The members of the regents candidate 17 18 advisory council shall choose a chairperson from among themselves. A majority of all the members to which the regents 19 candidate advisory council is entitled shall constitute a quorum 20 to conduct business. The concurrence of a majority of all the 21

members to which the regents candidate advisory council is

- 1 entitled shall be necessary to make any action of the regents
- 2 candidate advisory council valid. The regents candidate
- 3 advisory council shall meet annually and at other times as
- 4 necessary. The regents candidate advisory council shall be
- 5 exempt from part I of chapter 92.
- 6 (k) Members of the regents candidate advisory council
- 7 shall serve without compensation but shall be reimbursed for
- 8 expenses, including travel, board, and lodging expenses,
- 9 necessary for the performance of their duties.
- 10 (1) Any law to the contrary notwithstanding, all regents
- 11 candidate advisory council information shall be confidential,
- 12 including without limitations all council information obtained,
- 13 reviewed, or considered before and after council decision-
- 14 making. Confidential regents candidate advisory council
- 15 information shall include information and data that are not of
- 16 public record, including, without limitation, personal and
- 17 financial information; the names of applicants; applications and
- 18 the personal, financial, and other information contained therein
- 19 submitted by the applicants to the regents candidate advisory
- 20 council; interviews; schedules; reports; studies; background
- 21 checks; credit reports; and surveys and reports prepared for or
- 22 on the regents candidate advisory council's behalf; the results

MEANS:

for the Board of Regents need to reside in

the geographical location that they

represent. It amends the length of time (from thirty to sixty days) that the Regents candidate advisory council has to submit to

the Governor names of candidates for

specific seats following notification from

the governor of a vacancy due to resignation, death, or removal by the

governor.
