A BILL FOR AN ACT

RELATING TO PENALTIES FOR VIOLATIONS WITHIN THE CONSERVATION DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 183C-7, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$183C-7 Penalty for violation. (a) The department shall
- 4 prescribe administrative procedures as it deems necessary for
- 5 the enforcement of this chapter and any zoning rule adopted in
- 6 accordance therewith. These rules may be enforced by court
- 7 order at the suit of the department or of the owner or owners of
- 8 real estate directly affected by the rules. The provisions of
- 9 section 607-25 shall apply to this chapter.
- 10 (b) Any person violating this chapter or any rule adopted
- 11 in accordance with this chapter shall be fined not more than
- [\$2,000] \$15,000 per violation in addition to administrative
- 13 costs [and], costs associated with land or habitat restoration,
- 14 [or both, if required,] and damages to [state] public land[-] or
- 15 natural resources, or any combination thereof. After written or
- 16 verbal notification from the department, wilful violation of
- 17 this [section] chapter or any rule adopted in accordance with

- 1 this chapter may incur an additional fine of up to [\$2,000]
- 2 \$15,000 per day per violation for each day in which the
- 3 violation persists. The board may set, charge, and collect the
- 4 fine based on the value of the natural resource that is damaged,
- 5 the market value of the natural resource damaged, and any other
- 6 factor it deems appropriate, such as the loss of the natural
- 7 resource to its natural habitat and environment and the cost of
- 8 restoration or replacement. The remedies provided for in this
- 9 subsection are cumulative and in addition to any other remedies
- 10 allowed by law.
- 11 (c) This section shall not be construed to prohibit any
- 12 person from exercising native Hawaiian gathering rights or
- 13 traditional cultural practices as authorized by law or as
- 14 permitted by the department pursuant to article XII, section 7,
- 15 of the Hawaii Constitution."
- 16 SECTION 2. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 3. This Act shall take effect upon its approval.
