A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTIO	N 1. The purpose of this Act is to amend Act 56,
2	Session Law	s of Hawaii 2007, that establishes a candidate
3	advisory co	uncil for the board of regents of the University of
4	Hawaii in c	onformity with the amendment to article X, section 6
5	of the Hawa	ii State Constitution, ratified by the voters on
6	November 7,	2006. Specifically, this Act:
7	(1) R	equires the submission of candidates within sixty
8	đ	ays following notification from the governor of a
9	V	acancy due to resignation, death, or removal by the
10	g	overnor;
11	(2) R	equires the council to submit the names of candidates
12	t	o the governor;
13	(3) M	akes confidential all candidate advisory council
14	i	nformation before and after decisionmaking;
15	(4) R	equires that the candidate reside in the geographic
16	a	rea the candidate represents;

1	(5)	Requires the governor to notify the regents candidate
2		advisory council of vacancies on the board of regents
3		in a timely manner; and
4	(6)	Authorizes an administrator position to be established
5		to support the candidate advisory council and provides
6		for an appropriation of \$152,000 from general funds to
7		support candidate advisory council operations.
8	SECT	ION 2. Section 26-11, Hawaii Revised Statutes, is
9	amended by	y amending subsection (a) to read as follows:
10	"(a)	The University of Hawaii shall be headed by an
11	executive	board to be known as the board of regents.
12	The l	board shall consist of fifteen members. At least one
13	member sha	all be a University of Hawaii student at the time of
14	the initia	al appointment. This member may be reappointed for one
15	additiona	l term even though the member may no longer be a
16	student at	t the time of reappointment. The governor shall reduce
17	the terms	of those initially appointed to each seat on the board
18	of regents	s to provide, as far as practicable, for the expiration
19	of three t	terms each year; provided that the term of the student

member shall not be reduced.

1 At least twelve members, except for the student member, 2 shall represent and reside in the specified geographic areas as 3 follows: 4 (1) Two members from the county of Hawaii; Two members from the county of Maui; 5 (2) One member from the county of Kauai; and (3) Seven members from the city and county of Honolulu. 7 (4)The board shall have the power, in accordance with the 8 9 Constitution of the State and with law, to formulate policy and 10 to exercise control over the university through its executive officer, the president of the university. The board shall have 11 12 exclusive jurisdiction over the internal organization and 13 management of the university." 14 SECTION 3. Section 304A-104, Hawaii Revised Statutes, is amended to read as follows: 15 16 "§304A-104 Regents; appointment; tenure; qualifications; 17 meetings. (a) The affairs of the university shall be under the 18 general management and control of the board of regents 19 consisting of fifteen members who shall be appointed and may be removed by the governor. Except as otherwise provided by law, 20 21 state officers shall be eligible for appointment and membership. The term of each member shall be five years, except as provided 22



- 1 for the initial appointment in section 26-11; provided that the
- 2 term of the student member shall be two years. Every member may
- 3 serve beyond the expiration date of the member's term of
- 4 appointment until the member's successor has been appointed by
- 5 the governor and confirmed by the senate in accordance with
- 6 article X, section 6 of the state constitution. Members shall
- 7 serve no more than two consecutive five-year terms; provided
- 8 that the members who are initially appointed to terms of two
- 9 years or less pursuant to section 26-11(a) may be reappointed to
- 10 two ensuing five-year terms. If a member is to be appointed to
- 11 a second term of five years, the senate shall consider the
- 12 question of whether to reconfirm the member at least one hundred
- 13 twenty days prior to the conclusion of a member's first five-
- 14 year term; provided that if the senate is not in session within
- 15 one hundred twenty days prior to the conclusion of the member's
- 16 first five-year term, the member shall continue to serve until
- 17 the senate convenes for the next regular session or the next
- 18 special session for which the senate is authorized to consider
- 19 the question of reconfirmation.
- 20 (b) At its first meeting after June 30, the board of
- 21 regents shall elect a chairperson and vice-chairperson, who
- 22 shall serve until adjournment of its first meeting after June 30



- 1 of the next year or thereafter until their successors are
- 2 appointed. The board shall appoint a secretary, who shall not
- 3 be a member of the board. The president of the university shall
- 4 act as executive officer of the board. From May 1, 2007 and
- 5 until such time that the board of regents has at least fourteen
- 6 members, seven members of the board of regents shall constitute
- 7 a quorum to conduct business, and the concurrence of at least
- 8 seven members of the board of regents shall be necessary to make
- 9 any action of the board of regents valid; provided that upon
- 10 filling at least fourteen of the fifteen board of regents seats
- 11 required under subsection (a), a majority of the board of
- 12 regents shall constitute a quorum to conduct business, and the
- 13 concurrence of a majority of all the members to which the board
- 14 of regents is entitled shall be necessary to make any action of
- 15 the board of regents valid. The board shall meet at least ten
- 16 times annually and, from time to time, may meet in each of the
- 17 counties of Hawaii, Maui, and Kauai.
- (c) The governor shall notify the regents candidate
- 19 advisory council within ten days of receiving notification that
- 20 a member of the board of regents is resigning, has died, or is
- 21 being removed by the governor.

3	(d)	In making its presentations, the <u>regents</u> candidate
4	advisory	council shall:
5	(1)	Develop a statement that includes the selection
6		criteria to be applied and a description of the
7		responsibilities and duties of a member of the board
8		of regents and distribute this statement to potential
9		candidates;
10	(2)	Screen and qualify candidates for each position on the
11		board of regents based on their background,
12		experience, and potential for discharging the
13		responsibilities of a member of the board of regents;
14	(3)	Publicly advertise pending vacancies and actively
15		solicit and accept applications from potential
16		candidates;
17	(4)	Develop and implement a fair, independent, and
18		nonpartisan procedure for selecting candidates to
19		serve on the board of regents; and
20	(5)	Require each candidate to disclose any existing or
21		anticipated contracts with the University of Hawaii or

19	The regents candidate advisory council shall be selected in	
20	a wholly nonpartisan manner. If any member has not been	
21	appointed within one hundred eighty days of [the] May 1, 2007,	
22	the sitting members on the $\underline{\text{regents}}$ candidate advisory council	

- 1 shall make an interim appointment to fill the vacant seat. The
- 2 interim appointee shall satisfy the requirements for appointment
- 3 provided in this subsection and shall serve until the time when
- 4 the appropriate appointing authority makes an appointment for
- 5 the vacant seat as provided in this subsection. Appointees to
- 6 the regents candidate advisory council shall have a general
- 7 understanding of the purposes of higher education, the mission
- 8 of the University of Hawaii system, and the responsibilities of
- 9 the board of regents. Appointees shall be individuals who are
- 10 widely viewed as having placed the broad public interest ahead
- 11 of special interests, having achieved a high level of prominence
- 12 in their respective professions, and being respected members of
- 13 the community.
- 14 (q) Members of the regents candidate advisory council
- 15 shall serve four-year terms; provided that the three members
- 16 initially appointed by the governor, the president of the
- 17 senate, and the speaker of the house of representatives shall
- 18 serve for terms of two years; provided further that terms for
- 19 appointments of the initial members of the regents candidate
- 20 advisory council shall be deemed to begin on July 1, 2007,
- 21 regardless of the actual date of appointment.

- (h) If a vacancy occurs, a successor shall be appointed in
- 2 the same manner and subject to the same qualifications as the
- 3 person's predecessor. The person appointed to fill a vacancy
- 4 shall serve for the remainder of the term of the person's
- 5 predecessor.
- 6 (i) The regents candidate advisory council shall operate
- 7 in a wholly nonpartisan manner. No individual, while a member
- 8 of the regents candidate advisory council, shall run for or hold
- 9 any elected office under the United States or the State or any
- 10 of its political subdivisions.
- 11 (j) The regents candidate advisory council shall convene
- 12 its first meeting on or after thirty-one days from May 1, 2007;
- 13 provided that, if thirty days after May 1, 2007, all the members
- 14 to which the regents candidate advisory council is entitled have
- 15 not yet been appointed, the regents candidate advisory council
- 16 shall convene its first meeting upon the appointment of a
- 17 majority of its members. The members of the regents candidate
- 18 advisory council shall choose a chairperson from among
- 19 themselves. A majority of all the members to which the regents
- 20 candidate advisory council is entitled shall constitute a quorum
- 21 to conduct business. The concurrence of a majority of all the
- 22 members to which the regents candidate advisory council is



- 1 entitled shall be necessary to make any action of the regents
- 2 candidate advisory council valid. The regents candidate
- 3 advisory council shall meet annually and at other times as
- 4 necessary. The regents candidate advisory council shall be
- 5 exempt from part I of chapter 92.
- 6 (k) Members of the regents candidate advisory council
- 7 shall serve without compensation but shall be reimbursed for
- 8 expenses, including travel, board, and lodging expenses,
- 9 necessary for the performance of their duties.
- 10 (1) Notwithstanding chapter 92F or any other law to the
- 11 contrary, all information required by the regents candidate
- 12 advisory council shall be confidential, including, without
- 13 limitation, all council information obtained, reviewed, or
- 14 considered before and after council decisionmaking.
- 15 Confidential regents candidate advisory council information
- 16 shall include documents, data, or other information that are not
- 17 of public record, including, without limitation, personal
- 18 financial information; the names of applicants; applications and
- 19 the personal, financial, and other information contained therein
- 20 submitted by the applicants to the regents candidate advisory
- 21 council; interviews; schedules; reports; studies; background
- 22 checks; credit reports; surveys and reports prepared for or on



- 1 the regents candidate advisory council's behalf; the results of
- 2 any evaluations or assessments conducted by the regents
- 3 candidate advisory council; the substance and details of any
- 4 discussions with regents candidate advisory council members; and
- 5 the substance and details of discussions and deliberations of
- 6 the regents candidate advisory council and any of its committees
- 7 during meetings."
- 8 SECTION 5. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$152,000 or so much
- 10 thereof as may be necessary for fiscal year 2008-2009 to
- 11 establish a permanent administrative position for the regents
- 12 candidate advisory council.
- 13 The sum appropriated shall be expended by the University of
- 14 Hawaii for the purposes of this Act.
- 15 SECTION 6. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 7. This Act shall take effect upon its approval;
- 18 provided that section 5 shall be effective on July 1, 2008.

UH; Regents Candidate Advisory Council; Appropriation

Description:

Requires the submission of candidates' names for the regents candidate advisory council within sixty days following the notification of a vacancy. Clarifies the requirement of the submission of the names of the candidates to the governor.

Makes confidential all information received or maintained by the regents candidate advisory council. Requires candidates to reside in the geographic area which the candidate represents. Appropriates funds for an administrative position to support regents candidate advisory council operations. Requires the governor to notify the regents candidate advisory council of vacancies on the board of regents in a timely manner.
