# A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE HAWAII COUNTY ECONOMIC OPPORTUNITY COUNCIL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that recently immigrated
- 2 Marshallese to the district of Ka'u on the Big Island of Hawaii
- 3 are in dire need of help. The majority of the Marshallese
- 4 residents are low-income and living in poverty. The lack of
- 5 adequate services and facilities for this impoverished, rural
- 6 population keeps them economically, educationally, and socially
- 7 stagnant.
- 8 Most, if not all, of the Marshallese speak very little
- 9 English. As English is the dominant language prerequisite for
- 10 nearly every available job in the community, finding employment
- 11 becomes very difficult and therefore, many Marshallese adults
- 12 are unemployed and subsist on minimal income they receive from
- 13 reparation payments for the Bikini Atoll nuclear tests conducted
- 14 in the past by the United States. Language barriers also
- 15 prevent the Marshallese from access to social services,
- 16 including welfare and medical benefits for which they may be
- 17 eligible.

              Multiple families pool their limited resources to

    purchase a single lot and build several houses upon this single

    lot. The homes are basic shelters made of plywood nailed

    together and are without toilets and water lines. Electricity

    hook up is made with extension cords that run from one unit to
               The Marshallese dwell in crowded quarters with
    relatives, to such an extent that some children sleep on carpets
 8

    placed on the lava fields that serve as the floor or bed.

         The Hawaiian Ocean View Estates has no water line. Water
11
    must be fetched from public spigots, and most families lacking
12
    resources are only able to haul water to their homes by
13
    carpooling, thus hauling the water in quantities barely adequate
14
    for drinking and cooking, and only seldom for bathing and
15
    washing.

         An estimated one hundred fifty pre-school aged Marshallese
17
    children reside in the Hawaiian Ocean View Estates. A recent
18
    county community assessment has found that the Hawaii Ocean View
19
    Estate area needs additional early child care and education
20
    services with its high concentration of the Marshallese
21
    population. Most Marshallese students are underachievers in
22
    schoolwork due to their limited English proficiency. The school

- 1 enrollment of Marshallese students for the 2007-2008 school year
- 2 in the English as a second language program for the two public
- 3 schools are seventy per cent in Naalehu elementary and middle
- 4 school and seventy-seven per cent in Pahala elementary and Ka'u
- 5 high school.
- 6 Marshallese children are placed at a tremendous
- 7 disadvantage in receiving an adequate education due to language
- 8 barriers, as English is the standard language used in the
- 9 classrooms. Furthermore, because of a lack of adequate time
- 10 allotted for socializing in the tight after school
- 11 transportation schedule, there are increased cultural barriers
- 12 for Marshallese children to assimilate and intermingle after
- 13 school with children of other ethnicities.
- 14 Hawaii county economic opportunity council proposes to
- 15 prevent, alleviate, and eliminate the health, social, cultural,
- 16 and economic conditions faced by the Marshallese.
- 17 The purpose of this Act is to make an appropriation to the
- 18 department of labor and industrial relations, office of
- 19 community services, for the Hawaii county economic opportunity
- 20 council to implement new programs and to expand existing
- 21 programs to aid the Marshallese.

1	SECTION 2. There is appropriated out of the general	
2	revenues	of the State of Hawaii the sum of \$540,000 or so much
3	thereof a	s may be necessary for fiscal year 2008-2009 for the
4	Hawaii county economic opportunity council to assist the	
5	Marshallese in the county of Hawaii, for:	
6	(1)	A head start home-based program for preschool
7		children;
8	(2)	A language arts multicultural program for
9		underachieving elementary school students to raise
10		their academic achievement to a new higher level;
11	(3)	A dropout prevention ("right track program") for
12		at-risk students to graduate from high school;
13	(4)	Employment core services program for low-income person
14		to obtain employment; and
15	(5)	One fourteen passenger van.
16	The	sum appropriated shall be expended by the department of
17	labor and	industrial relations, office of community services,
18	for the purposes of this Act.	
19	SECT	ION 3. This Act shall take effect on July 1, 2008.
