# A BILL FOR AN ACT

RELATING TO AQUATIC RESOURCES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the aquatic
- 2 resources of Hawaii are in danger. The replenishment and
- 3 conservation of these resources are vital to the economic,
- 4 cultural, environmental, health, and social well-being of the
- 5 state's residents, visitors, and future generations. In
- 6 addition, the state's marine ecosystems are vital to global
- 7 biodiversity. The legislature further finds that adverse
- 8 effects on the size, number, distribution, diversity, and
- 9 quality of important marine species and habitats may be reversed
- 10 by assessing and mitigating activities that affect the marine
- 11 ecosystem.
- 12 The purpose of this Act is to require the department of
- 13 land and natural resources to provide a comprehensive report on
- 14 the status of the state's marine ecosystems.
- 15 SECTION 2. The department of land and natural resources
- 16 shall compile a report that contains information and data on the
- 17 following:



1	(1)	The current character of the state's aquatic
2		ecosystem;
3	(2)	Effects on the aquatic ecosystems and fishery
4		resources of the state from:
5		(A) Development, including shore-based activities and
6		non-fishing activities;
7		(B) Alien species;
8		(C) Runoff and sedimentation;
9		(D) Harvesting of marine organisms;
10		(E) Pollution;
11		(F) Fresh water inputs; and
12		(G) Other relevant sources and activities;
13	(3)	Proposed actions to mitigate effects on aquatic
14		ecosystems, including anticipated results, a scheduled
15		evaluation process, and strategies to assess
16		effectiveness; and
17	(4)	Relevant material from resources, including the
18		national "State of the Coral Reef Ecosystems of the
19		United States and Pacific Freely Associated States,"
20		the National Oceanographic and Atmospheric
21		Administration Coral Reef Conservation Program, Hawaii
22		grant-funded projects and other relevant projects

1	(Hawaii's Local Action Strategies - Plans and			
2	Projects), the Hawaii Conservation Alliance			
3	proceedings, the health condition of Hawaii's			
4	resources annual report, and the Hawaii Ocean			
5	Resources Management Plan priority areas progress			
6	reports.			
7	SECTION 3. There is appropriated out of the general			
8	revenues of the State of Hawaii the sum of \$ or so much			
9	thereof as may be necessary for fiscal year 2008-2009 for a			
10	comprehensive report on the status of the state's aquatic			
11	resources; provided that the appropriation may be used to			
12	contract for relevant expertise to perform the study.			
13	The sum appropriated shall be expended by the department of			
14	land and natural resources for the purposes of this Act.			
15	SECTION 4. The department of land and natural resources			
16	shall submit an interim report to the legislature no later than			
17	twenty days prior to the convening of the regular session of			
18	2009, and shall submit a final report on its findings and			
19	recommendations, including any proposed legislation, to the			
20	legislature no later than twenty days prior to the convening of			
21	the regular session of 2012. The final report shall include:

1	(1)	An analysis of the effects and benefits of the
2		recommendations;
3	(2)	A record of stakeholders' assistance and input; and
4	(3)	The supporting rationale and data for the proposed
5		recommendations.
6	SECT	ION 5. This Act shall take effect on July 1, 2020.
