A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE STATE COMMISSION ON THE STATUS OF WOMEN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The mission of the Hawaii state commission on
- 2 the status of women is to ensure equality for women and girls in
- 3 the State by acting as a catalyst for positive change through
- 4 advocacy, education, collaboration, and program development.
- 5 The duties of the Hawaii state commission on the status of women
- 6 are established by statute.
- 7 SECTION 2. For the twelfth year, the Hawaii state
- 8 commission on the status of women is organizing women's health
- 9 month. The purpose of women's health month is to maximize
- 10 public awareness of women's health issues, empower women to be
- 11 their own health advocates, reduce health care disparities, and
- 12 promote the physical and emotional well-being of women in
- 13 Hawaii. The month of events include education workshops, health
- 14 fairs, lectures, fitness activities, and other special events.
- In March 2006, the Hawaii state commission on the status of
- 16 women began the process to establish a collection of Hawaii

- 1 women's oral history. Oral histories will be collected annually
- 2 leading up to the women's history month in March.
- 3 In 1998, the Center for American Women and Politics, a unit
- 4 of the Eagleton Institute of Politics at Rutgers University,
- 5 created the ready to run program as a bi-partisan effort to
- 6 recruit and train women to run for all levels of political
- 7 office. The Center for American Women and Politics has made
- 8 it's ready to run program available to state commissions on the
- 9 status of women around the country. The goal is to present a
- 10 ready to run training workshop in 2007, at the end of the
- 11 legislative session.
- 12 The wage club project has launched a collaborative
- 13 grassroots program designed to help close the wage gap between
- 14 women and men at work. The Hawaii state commission on the
- 15 status of women will facilitate a series of discussion and
- 16 training groups around the State to examine wage inequities with
- 17 the goal of defining grassroots driven multi-faceted solutions
- 18 to the problem.
- 19 SECTION 3. The purpose of this Act is to appropriate
- 20 funding to the Hawaii state commission on the status of women
- 21 for programming, travel, and office expenses. This
- 22 appropriation is in addition to funding currently allocated to

- 1 the department of human services in the amounts of \$102,236 for
- 2 personnel expenses and \$3,044 for miscellaneous expenses.
- 3 SECTION 4. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$53,700, or so much
- 5 thereof as may be necessary for fiscal year 2007-2008, to the
- 6 Hawaii state commission on the status of women for programming,
- 7 travel, and office expenses; provided that moneys appropriated
- 8 by this Act shall not be construed to diminish any other funding
- 9 provided to the commission on the status of women by the
- 10 department of human services or any other state source of
- 11 revenue.
- 12 The sum appropriated shall be expended by the department of
- 13 human services for the purposes of this Act.

14 SECTION 5. This Act shall take effect on July 1, 2007.
