HOUSE CONCURRENT RESOLUTION

REQUESTING THE PROCUREMENT OFFICER OF THE DEPARTMENT OF TRANSPORTATION TO PREPARE A REPORT EXPLAINING THE PROCUREMENT PROCESS USED TO AWARD THE HONOLULU WIKI WIKI SERVICE CONTRACT.

WHEREAS, the Hawaii State Legislature is committed to 1 ensuring that the State's procurement process and laws are 2 3 followed; and 4 5 WHEREAS, the Hawaii State Legislature, in light of the layoffs at Aloha Airlines and All Trans Airways (ATA), believes 6 that the preservation of jobs and employment opportunities in 7 8 Hawaii is important and that employees should be protected from losing their jobs simply because there is a change in the 9 employer who is providing services to the state; and 10 11 WHEREAS, when a state contract is awarded that replaces an 12 existing contractor with a new contractor, existing workers who 13 have demonstrated the ability to perform the work should be 14 hired by the new contractor; and 15 16 WHEREAS, the State recently awarded a contract to operate 17 the Wiki Wiki Shuttle to a new contractor; and 18 19 WHEREAS, previous contractors, when awarded the Wiki Wiki 20 21 Shuttle contract, hired all the former contractor's employees; and 22 23 WHEREAS, it is in the best interest of the state, public 24 safety, and the tourism industry that employees of the Wiki Wiki 25 Shuttle are experienced in performing the functions of the Wiki 26 Wiki Shuttle and related services in and around the Honolulu 27 International Airport; and 28

WHEREAS, the new contractor for the Wiki Wiki Shuttle has
 refused to hire a majority of the former contractor's employees,
 even though these employees have experience operating the Wiki
 Wiki Shuttle; now, therefore,

BE IT RESOLVED by the House of Representatives of the 6 Twenty-fourth Legislature of the State of Hawaii, Regular 7 Session of 2008, the Senate concurring, that the procurement 8 9 officer of the State Department of Transportation's Airports Division is requested to prepare a report explaining the 10 procurement process for the awarding of the Wiki Wiki Shuttle 11 12 service contract and include in this report the reasons for the decision of the new contractor to not hire the employees of the 13 former contractor and the steps, if any, taken by the 14 15 procurement officer to protect the jobs of these employees; and 16

17 BE IT FURTHER RESOLVED that the Department of 18 Transportation is urged to consider rebidding the Wiki Wiki 19 Shuttle service contract and inserting a provision into the 20 contract that requires the hiring of the employees of the 21 previous contractor; and

BE IT FURTHER RESOLVED that certified copies of this
Concurrent Resolution be transmitted to the Director of the
Department of Transportation.
