## HOUSE RESOLUTION

URGING THE BOARD OF EDUCATION TO ONLY PURCHASE OR LEASE LARGE SCHOOL BUSES THAT HAVE AN OPERABLE SEAT BELT ASSEMBLY AT ALL DESIGNATED SEATING POSITIONS AND SEAT BACKS THAT ARE AT LEAST TWENTY-FOUR INCHES IN HEIGHT.

WHEREAS, federal and state laws require certain motor 1 2 vehicle drivers and passengers to use seat belts because seat belts provide a measure of protection during accidents; and 3 4 5 WHEREAS, passenger cars, light trucks, and vans are required under federal law to have seat belts at all designated 6 7 seating positions; and 8 WHEREAS, neither federal nor Hawaii law requires seat belts 9 on school buses that have a gross vehicle weight rating of more 10 than ten thousand pounds, which is the standard weight of a 11 12 large school bus; and 13 WHEREAS, despite increased federal standards for school bus 14 passenger safety and crash protection, there are still thousands 15 of injuries to children throughout the country each year due to 16 school bus accidents; and 17 18 WHEREAS, children suffer both minor and serious injuries to 19 20 their head, neck, back, and stomach when striking the roof, windows, seat backs, and other school bus passengers during 21 crashes; and 22 23 WHEREAS, opponents of seat belts on large school buses 24 argue that strong, well-padded, energy absorbing seats and 25 higher seat backs compartmentalize passengers during a crash, 26 thereby providing adequate safety; and 27 28 WHEREAS, a comprehensive, in-depth study in 1989 by the 29 Transportation Research Board found that seat belts provide 30 additional crash protection on compartmentalized school buses; 31 and 32 33

WHEREAS, in addition, a National Highway Traffic Safety 1 Administration study found that approximately one-third of the 2 3 fatal crashes between 1977 and 1992 were non-frontal crashes from which compartmentalization is not designed to protect; and 4 5 WHEREAS, most school bus fatalities occur in rollovers; and 6 7 WHEREAS, crash test and case study data indicate that seat 8 9 belts provide improved crash protection and are especially beneficial in side-impact and rollover school bus accidents; and 10 11 12 WHEREAS, seat belts also reduce other types of injuries by restraining children who may otherwise be out of their seats, 13 thereby improving passenger behavior and reducing distractions 14 to school bus drivers; and 15 16 WHEREAS, California, Florida, Louisiana, New Jersey, and 17 New York require school buses to meet a higher safety standard 18 than established under federal law; now, therefore, 19 20 BE IT RESOLVED by the House of Representatives of the 21 Twenty-fourth Legislature of the State of Hawaii, Regular 22 Session of 2008, that the Board of Education is urged to only 23 24 purchase or lease large school buses that have an operable seat belt assembly at all designated seating positions and seat backs 25 that are at least twenty-four inches in height; and 26 27 BE IT FURTHER RESOLVED that the Board of Education is urged 28 29 to adopt rules requiring the use of seat belt assemblies, when available, by pupils and appropriate school discipline for any 30 pupil in violation; and 31 32 BE IT FURTHER RESOLVED that certified copies of this 33 Resolution be transmitted to the Chairperson of the Board of 34 35 Education and the Superintendent of Education. 36 37 38
