## HOUSE RESOLUTION

REQUESTING THE CIVIL DEFENSE DIVISION OF THE DEPARTMENT OF DEFENSE TO CONDUCT A STUDY TO DETERMINE THE FEASIBILITY OF ALLOWING THE FACILITIES AT LUALUALEI, WHICH ARE OWNED BY THE UNITED STATES NAVY, TO BE USED AS AN EMERGENCY SHELTER FOR CIVILIANS.

WHEREAS, natural disasters appear to be increasing in 1 2 frequency and intensity; and 3 WHEREAS, the State must have a comprehensive emergency 4 5 preparedness program to mitigate hazards, enhance preparedness for major disasters, and accelerate response and recovery when 6 7 disaster strikes; and 8 9 WHEREAS, current concerns and challenges for the State Civil Defense are the lack of emergency spaces throughout the 10 state, evacuation of tourists and residents, evacuation of the 11 special needs population, special needs emergency shelters, and 12 13 the development and maintenance of plans, public awareness and 14 involvement; and 15 16 WHEREAS, plans to protect the public health, safety, and welfare during disasters caused by fire, flood, tidal wave, 17 earthquake, or other natural causes and enemy attack, sabotage, 18 and other hostile action must be made to ensure the ability for 19 people to move quickly and efficiently to safe shelters; and 20 21 WHEREAS, the communities of Waianae, Makaha, Makua, Honokai 22 23 Hale, Nanakuli, and Lualualei have only one major roadway with which to enter or exit their districts and in a time of 24 emergency this highway can easily become congested or even shut 25 26 down completely; and

1 WHEREAS, shelters for the people on the west coast of Oahu need to be in a close and convenient location, large enough to 2 handle evacuees from the area, and structurally able to bear the 3 brunt of disasters such as hurricanes; 4 5 WHEREAS, about 1,700 acres at Lualualei were taken from the 6 Hawaiian Home Lands in 1930 and 1933 under federal executive 7 orders when Hawaii was a territory and turned over to the Navy 8 9 for ammunition storage; and 10 WHEREAS, within the valley at the base of the Waianae 11 12 Mountain range are 266 underground and above-ground ammunition storage areas that make up the Lualualei Naval Magazine; and 13 14 WHEREAS, the facilities in the Lualualei Naval Magazine may 15 make an ideal site for emergency shelters due to their location 16 17 and the structural integrity of the bunker-style storage areas; now, therefore, 18 19 20 BE IT RESOLVED by the House of Representatives of the Twenty-fourth Legislature of the State of Hawaii, Regular 21 Session of 2008, that the Civil Defense Division of the 22 23 Department of Defense is requested to conduct a study to 24 determine the feasibility of allowing the facilities at Lualualei, which are owned by the United States Navy, to be used 25 as an emergency shelter for civilians; and 26 27 28 BE IT FURTHER RESOLVED that the feasibility study should examine: 29 30 Any necessary agreements between the State and the 31 (1) United States Navy; 32 33 The sufficiency and capacity of the facilities to 34 (2) provide emergency shelter; 35
