## A BILL FOR AN ACT

RELATING TO VOTING.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 15-4, Hawaii Revised Statutes, is 1 2

amended to read as follows: "§15-4 Request for absentee ballot. (a) Any person 3 4 registered to vote may request an absentee ballot in person or 5 in writing from the clerk not earlier than on the sixtieth day and not later than 4:30 p.m. on the seventh day prior to the 6 7 election. Any mailed requests for an absentee ballot shall be 8 mailed by the person directly to the clerk. The clerk may waive 9 any or all of the foregoing requirements in special cases as 10 provided in the rules adopted by the chief election officer. 11 The request shall include information such as the person's 12 social security number, date of birth, and the address under which the person is registered to vote. The request shall also 13 14 include the address to which the person wishes the requested 15 ballot forwarded. The request, when made for any primary or

special primary election, may include an additional request for

an absentee ballot to be voted at any election immediately

- 1 following the primary or special primary; provided the person so
- 2 indicates in the person's request.
- 3 Subsequent to the closing of registration for each
- 4 election, the clerk may mail a request form for an absentee
- 5 ballot to each voter in a remote area who has not already made
- 6 such a request. The request form shall be accompanied by:
- 7 (1) A stamped, self-addressed envelope; and
- 8 (2) Instructions regarding the manner of completing and
- 9 returning the request form.
- 10 (b) Notwithstanding subsection (a), the clerk shall mail
- 11 an absentee ballot for each primary, special primary, special,
- 12 general, and special general election to each registered voter
- 13 who resides in the county of Kalawao. The chief election
- 14 officer may adopt rules to carry out this subsection.
- 15 (c) When a registered voter requests an absentee ballot,
- 16 the voter also may include an additional request to receive
- 17 absentee ballots permanently. After receiving a request for
- 18 permanent absentee voter status, the clerk shall mail to the
- 19 voter who requested permanent absentee voter status an absentee
- 20 ballot for all subsequent elections conducted in that precinct.

- 3 SECTION 2. Section 15-11, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "§15-11 Voting by absentee voter at polls prohibited. Any
- 6 person having voted an absentee ballot pursuant to this
- 7 [section] chapter shall not be entitled to cast a ballot at the
- 8 polls on election day. An absentee voter who does cast a ballot
- 9 at the polls shall be guilty of an election offense under
- 10 section 19-3(5)."
- 11 SECTION 3. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2007-2008 for
- 14 the purpose of implementing and administering the permanent
- 15 absentee voter program.
- 16 The sum appropriated shall be expended by the office of
- 17 elections for the purposes of this Act.
- 18 SECTION 4. Statutory material to be repealed is bracketed
- 19 and stricken. New statutory material is underscored.

- 1 SECTION 5. This Act shall take effect on January 1, 2008;
- 2 provided that section 3 shall take effect on July 1, 2007.
