## A BILL FOR AN ACT

RELATING TO CREATIVE MEDIA.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

2 SECTION 1. The legislature finds that in 2007, emerging 3 creative media programs at the University of Hawaii academy for 4 creative media, at Waianae high school, or within a broad range 5 of multidisciplinary programs like Project EAST on the neighbor 6 islands have now achieved a specific level of achievements to 7 evaluate their performance in the context of what a globally-8 integrated economy requires. As pointed out by New York Times columnist Thomas Friedman, in his recent op-ed commentary 9 10 endorsing the National Center on Education and the Economy's 11 report: "We need to radically overhaul . . . an education 12 system designed in the 1900's for people to do 'routine work' 13 and refocus it on producing people who can imagine things that 14 have never been available before, who can create ingenious 15 marketing and sales campaigns, write books, build furniture, 16 make movies and design software that will capture people's

- 1 imaginations and become indispensable for millions"
- 2 (December 13, 2006, New York Times).
- 3 Just as Waianae Searider Productions has demonstrated the
- 4 transformational power of multi-media literacy to engage our
- 5 most at-risk students, and Project EAST students have
- 6 distinguished themselves in national competitions with their
- 7 homegrown science-technology and multimedia skills, Hawaii has
- 8 the opportunity to establish itself as a true "crossroads of the
- 9 Pacific" for digital and musical education. It is time for
- 10 Hawaii to take full advantage of its natural constituency with
- 11 the countries of the Pacific rim and the rising tide of global
- 12 popular culture in all its forms (including video games,
- 13 animation, indigenous film, and music) leveraging Hawaii's
- 14 inherent strengths.
- 15 The purpose of this Act is to provide financial incentives
- 16 and appropriate funds for the growth of Hawaii's creative media.
- 17 PART II
- 18 SECTION 2. Since being approved by the University of
- 19 Hawaii board of regents three years ago, the academy for
- 20 creative media is the fastest growing program at the University
- 21 of Hawaii. With two hundred seventy enrolled students
- 22 (including forty-five majors) who fill two hundred fifty-three

- 1 seats in twenty-nine courses in film production, screenwriting,
- 2 indigenous filmmaking, computer animation, critical studies, and
- 3 video game design. More than three hundred fifty original short
- 4 films and video games have been written, directed, and produced
- 5 by students that reflect their unique diversity and backgrounds.
- 6 Over forty student films were screened at film festivals from
- 7 Atlanta to Shanghai, including the Hawaii International Film
- 8 Festival 2004-2006. Students are offered internship
- 9 opportunities with major motion picture productions (Superman
- 10 Returns) and television shows (LOST and local morning news
- 11 shows), and have opportunities to showcase their work on local
- 12 television, such as commercials for Toyota/Scion of Hawaii,
- 13 which were entirely produced by students.
- 14 The school recently received a total of \$795,600 that was
- 15 privately raised or gifts from generous donors and supporters to
- 16 build, expand, and install the school's animation render farm, a
- 17 bank of over fifty computers that efficiently converts, assigns,
- 18 and monitors animation projects, at Leeward community college.
- 19 The animation render farm project will provide system-wide
- 20 animation computing power, via the Internet, to digital media
- 21 programs on all of the University of Hawaii campuses and Hawaii
- 22 schools. Furthermore, a \$500,000 federal grant was received for

- the school to produce an original documentary on statehood,
  which is currently in post-production.
  The purpose of this part is to:
- 4 (1) Authorize the academy for creative media to utilize
  5 applicable tax credits for the financing,
  6 construction, and equipping of the academy for
  7 creative media at the University of Hawaii; and
- 8 (2) Appropriate funds for the planning, design, and
   9 construction for a permanent facility for the academy
   10 of creative media.
  - SECTION 3. Notwithstanding any law to the contrary, including any law that may either limit or disqualify the costs associated with the planning, design, and construction of a permanent facility for the academy for creative media at the University of Hawaii from utilizing the tax credits available under Act 221, Session Laws of Hawaii 2001, or any other tax credit provisions that may apply, any applicable tax credit relating to digital media, film, television, or new market development, or any combination of general funds and tax credits may be utilized for the financing of the construction and equipping of the academy for creative media at the University of

section 4. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ , or so much thereof as may be necessary for fiscal year 2007-2008, and the same sum, or so much thereof as may be necessary for fiscal year 2008-2009, for the planning, design, and construction of a permanent facility for the academy for creative media at the University of Hawaii.

The sums appropriated shall be expended by the University

9 of Hawaii for the purposes of this Act.

11 SECTION 5. The legislature finds that as one of the 12 fastest growing industries in Hawaii, the digital media industry 13 requires a local incubator facility to provide a cohesive and 14 integrated site for developing the infrastructure for film and 15 television productions and interactive game development. This 16 incubator would be a state-of-the-art mixed use facility that 17 combines industry, government, and academic entities. In 18 addition to providing a collaborative learning environment for 19 students, faculty, and professionals in the field, the facility 20 would serve as an incubator for digital media businesses and as 21 a research and development lab for the creation of intellectual 22 property.

The purpose of this part is to establish and fund a digital 1 2 media incubator facility. 3 SECTION 6. The department of business, economic 4 development, and tourism, in coordination with the University of 5 Hawaii, shall oversee the leasing, operating, and maintenance of 6 a digital media incubator facility. The department may enter 7 into contracts with other government agencies, the county 8 economic development boards, other nonprofit organizations, or 9 for-profit firms for the purpose of the program. 10 The facility shall be leased to a mix of anchor tenants, 11 virtual tenants, and project-based tenants. For the purposes of 12 this Act: 13 (1) Anchor tenants are digital media companies with a regular cash flow that need a fixed address and would 14 15 benefit from sharing a common environment with other digital media companies; 16 17 (2) Virtual tenants may be less developed companies with 18 uneven cash flow that are just starting out and may need a place to do business from time to time; and 19 20 Project-based tenants are television and film (3) 21 production teams that need to lease space for a finite

amount of time to complete a particular project.

- SECTION 8. The legislature further finds that Hawaii's 1 2 music industry is an established segment of Hawaii's creative 3 media industries sector, with a growing popularity reaching far 4 beyond the shores of our island state. Full recognition of the 5 merits of Hawaiian music came in 2005 when the National Academy 6 of Recording Arts and Sciences announced the creation of a 7 Hawaiian music category in its annual Grammy Awards, the world's 8 most prestigious music awards program. 9 While Hawaii has an unusually high concentration of raw 10 musical talent and industry professionals, it lacks the 11 technical support infrastructure to assist individuals in the progression of their careers and businesses. 12 The University of Hawaii, Honolulu community college, has 13 been working to build alliances with national and local members 14 15 of the entertainment industry for the music and enterprise 16 learning experience program. The music and enterprise learning 17 experience (MELE) program combines short-term professional 18 training workshops, songwriter seminars, an associate degree 19 program in music business and production, and a transfer program that allows students to matriculate in Belmont University's 20 21 music and entertainment management programs. Belmont 22 University, located in Nashville, Tennessee, is one of the

- 1 premier music and entertainment educational programs in the
- 2 nation.
- 3 The purpose of this part is to establish a music and
- 4 enterprise learning experience program at the University of
- 5 Hawaii-Honolulu community college to develop the technical
- 6 business skills required by Hawaii's music artists and music
- 7 industry.
- 8 SECTION 9. There is established at the University of
- 9 Hawaii-Honolulu community college campus the music and
- 10 enterprise learning experience program to expand the existing
- 11 industry capacity, and to create new technological,
- 12 intercultural, and genre-bending forms of music through
- 13 creativity and professional business expertise. The program
- 14 will be developed around three primary components:
- 15 (1) Artist creativity;
- 16 (2) Entertainment business expertise; and
- 17 (3) Technical production skills.
- 18 The program will collaborate with Belmont University of
- 19 Nashville, Tennessee, on the joint use of Belmont's curriculum,
- 20 technical facilities and equipment specifications, training,
- 21 dual credit course offerings, and will also offer internships in
- 22 some of the most varied music environments in the world.

1 The program will be seeded through a title III Developing Institutions grant that has been awarded to Honolulu community 2 3 college native Hawaiian center, and will provide for some basic 4 program development of course offerings in coordination with 5 Belmont University of Nashville, Tennessee. 6 SECTION 10. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ , or so 8 much thereof as may be necessary for fiscal year 2007-2008, and 9 the sum of \$ , or so much thereof as may be necessary 10 for fiscal year 2008-2009, to carry out the purposes of leasing, 11 operating, and maintaining a music and entertainment business 12 training center. 13 The sums appropriated shall be expended by the University 14 of Hawaii-Honolulu community college for the purposes of this 15 Act.

SECTION 11. This Act shall take effect on July 1, 2007.
