A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE STATE COMMISSION ON FATHERHOOD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature established the state		
2	commission on fatherhood in 2003, in recognition of the		
3	important and unique role fathers play in the lives of their		
4	children, families, and communities. Act 156, Session Laws of		
5	Hawaii 2003, as subsequently amended, directs the commission to		
6	serve in an advisory capacity to state agencies to promote		
7	healthy family relationships between parents and children. In		
8	recognition of its value and the need to continue to promote and		
9	support healthy families in Hawaii, in 2007, the legislature		
10	established the commission as a permanent entity within the		
11	State.		
12	The legislature further finds that it is necessary for the		
13	commission to hire an executive director and appropriate staff		
14	to implement its strategic plan that includes the following		

(1) Completing a statewide analysis of service provisionto fathers;
