## A BILL FOR AN ACT

RELATING TO GRAFFITI.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 708, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Penalty for graffiti. (1) In addition to the 5 penalties provided under this part, if the property damage 6 involves graffiti, the court shall order the defendant to: 7 Remove the graffiti from the affected property; and (a) 8 Perform twenty hours of community service to remove (b) 9 graffiti from other properties. 10 (2) As used in this section, "graffiti" means any 11 unauthorized drawing, inscription, figure, or marking created by 12 paint, ink, chalk, dye, or similar substances." 13 SECTION 2. Section 577-3.5, Hawaii Revised Statutes, is 14 amended by amending subsection (b) to read as follows: 15 "(b) In addition to any other lawful orders, if a minor is found under chapter 571 to have committed an act constituting 16

Property Damage; Graffiti

### Description:

Requires minors who commit graffiti to remove their graffiti from the affected property and to perform community service to remove graffiti from other properties.
