A BILL FOR AN ACT

RELATING TO SEXUAL ASSAULT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that mentally disabled
- 2 persons need additional protection from sexual predators. Among
- 3 adults who are developmentally disabled, as many as 83 per cent
- 4 of the females and 32 per cent of the males are victims of
- 5 sexual assault. Further, anywhere from 15,000 to 19,000 people
- 6 with developmental disabilities are sexually assaulted each year
- 7 in the United States. Forty per cent of people with
- 8 developmental disabilities who are victims of sexual violence
- 9 will experience ten or more abusive incidents.
- 10 The legislature further finds that mentally disabled
- 11 persons and developmentally disabled persons have limited, if
- 12 any, capacity to give knowing and willing consent to sexual
- 13 acts. This inability to consent closely parallels the inability
- 14 of certain minors and prison inmates to consent.
- 15 In State v. Buch, 83 Hawaii 308, 926 P2d. 599 (1996), the
- 16 Hawaii supreme court, citing the Michigan supreme court in

         "It is well-established that the Legislature may, pursuant
         to its police powers, define criminal offenses without

         because of the need to protect children[.]"

         Just as the legislature in the past extended protection
13
    against sexual assault to minors under a certain age, the
14
    legislature finds a similar need to extend protection to
15
    mentally disabled persons who similarly lack the capacity to
16
    consent to sexual acts. The purpose of this Act is to hold
    perpetrators strictly liable for sexual assault against persons
17

    who are mentally defective.
         SECTION 2. Section 707-730, Hawaii Revised Statutes, is

15	not be construed to prohibit a law enforcement officer from

18	SECTION 4. This Act does not affect rights and duties that
19	matured, penalties that were incurred, and proceedings that were
20	begun, before its effective date.
