A BILL FOR AN ACT

RELATING TO HIGH TECHNOLOGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 150, Session Laws of Hawaii 2007, is 2 amended as follows: 3 1. By amending section 1 to read: "SECTION 1. [The legislature finds that private developers 4 5 are developing a four hundred thousand square foot class A life sciences research complex on 4.98 acres in the Kakaako district 6 of Oahu, adjacent to the University of Hawaii John A. Burns 7 school of medicine. The complex will be the only facility in 8 9 Hawaii with class A wet laboratory space available to the non-10 institutional market and is positioned to be a catalyst spawning new international life science collaborations in the Pacific Rim 11 for both public and private sectors. 12 13 The high technology development corporation is currently 14 negotiating a ten-year lease agreement for approximately sixty-six thousand square feet of laboratory and office space on 15 three floors of the development. The corporation will operate a 16 17 technology incubator and innovation center in the leased space,

    which will support the efforts of the adjacent University of
    Hawaii school of medicine, Cancer Research Center of Hawaii, and
 2
    many related bioscience research institutions.

         The center will allow the high technology development
 4
 5
    corporation to grow Hawaii's fledgling life-sciences industry by
    providing qualified start-up companies with high-quality
 6
 7
    incubator and innovation facilities. Currently, very little
 8
    suitable specialty commercial laboratory space exists in
 9
    Hawaii. Thirteen biotechnology companies did not select Hawaii
    as a site in the past three years due to the lack of suitable
10
    space. These companies needed twice as much space as will
11
    become available in the life sciences research complex, with the
12
13
    demand for space increasing even more.
14
         The center will also support Hawaii's fledgling start-up
    high technology companies by reducing the risk and cost for
15
    these start-up companies. Once these companies achieve
16

    financing, it is critical that they commit their core capital to
    research, rather than the security needed to finance business
18
19
    infrastructure such as complex and expensive wet laboratory
20
    developments.

         Many other jurisdictions are aggressively recruiting
22
    technology companies and start-ups and have undertaken similar

. 1	efforts to create a life-sciences industry in communities such
2	as San Diego, San Francisco, Boston, and North Carolina. New
3	York uses a \$2,000,000,000 initiative fund to lure top tier
4	biotechnology and pharmaceutical companies. The Kobe city
5	government has paid for two-thirds of the development of the
6	Kobe Bio Science Park in Kobe, Japan. These jurisdictions
7	attract high technology companies by offering grants, subsidies,
8	and other incentives to develop and grow businesses.
9	The competition to attract high technology companies is
10	intense, and governments have had to lend financial support to
11	compete in this market. They do so because high technology
12	companies hire the knowledge and concept workers that are
13	attracted by high-paying jobs and the opportunity to collaborate
14	with other scientists and technicians. These jurisdictions know
15	that high-technology industries produce high-quality jobs at all
16	levels, from the beginning technician to the senior researcher,
17	increase the jurisdiction's tax base and, most importantly,
18	provide the critical mass and synergy for a sustainable
19	industry.
20	The most successful states and communities locate their
21	technology companies adjacent to major research institutions,
22	creating a cluster effect. Hawaii's life sciences research

1 complex will be located next to the recently completed 2 University of Hawaii school of medicine in Kakaako, which will soon be joined by the Cancer Research Center of Hawaii and a 3 regional biosafety laboratory. 4 5 The life sciences research complex is intended to be the catalyst for the development of the life-sciences industry in 6 Hawaii and a place where the private research sector joins with 7 the public research sector for innovation and entrepreneurship 8 9 in the Kakaako core. It will more than double innovation space 10 in Kakaako for future cluster growth, ultimately resulting in a 11 total of four hundred thousand square feet of laboratory and 12 office space dedicated to the high-technology industry. 13 The life sciences research complex will, in addition to new and meaningful career pathways for Hawaii's youth and residents, 14 15 create an estimated one thousand new living-wage jobs. The 16 project will allow the State to take the initiative in expanding 17 incubation and innovation space for the life-sciences industry without bearing the cost or burden of construction alone. 1 18 The purpose of this Act is to [support the development of 19 the life-sciences industry in Hawaii by providing funding for a 20 21 ten-year lease and the operations and programs of a state-22 operated technology incubator and innovation center in a life SB2394 HD2 HMS 2008-3479
