A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE HAWAII HEALTH SYSTEMS CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. This emergency appropriation is necessary to
- 5 ensure that the Hawaii health systems corporation can pay for
- 6 operation and provision of current levels of service at Leahi
- 7 hospital, Maluhia, Samuel Mahelona memorial hospital, Lana'i
- 8 community hospital, Hilo medical center, Ka'u hospital, Kona
- 9 community hospital, Kohala hospital, and Maui memorial medical
- 10 center.
- 11 The purpose of this Act is to appropriate \$25,000,000 in
- 12 general funds for fiscal year 2007-2008 to adjust accounts
- 13 payable remittances to no more than forty-five days from the
- 14 date of the invoice for Hawaii health systems corporation's
- 15 facilities in order to bring current accounts payable balances
- 16 that are due to essential vendors. This will allow delivery of
- 17 goods and services to these facilities to continue on a timely

- 1 basis so that the facilities will be able to maintain
- 2 operations.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$14,000,000 or so
- 5 much thereof as may be necessary for fiscal year 2007-2008 for
- 6 the Hawaii health systems corporation to pay accounts payable
- 7 within forty-five days from the date of the invoice for Hawaii
- 8 health systems corporation's facilities, excluding the Maui
- 9 memorial medical center located in the Maui region of the Hawaii
- 10 health systems corporation.
- SECTION 4. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$11,000,000 or so
- 13 much thereof as may be necessary for fiscal year 2007-2008 for
- 14 Maui memorial medical center; provided that the sum appropriated
- 15 under this section shall only be expended if the operating loan
- 16 that is being negotiated by Maui memorial medical center does
- 17 not close prior to April 4, 2008.
- 18 SECTION 5. The sums appropriated shall be expended by
- 19 Hawaii health systems corporation for the purposes of this Act.
- 20 SECTION 6. If any provision of this Act, or the
- 21 application thereof to any person or circumstance is held
- 22 invalid, the invalidity does not affect other provisions or

- 1 applications of the Act, which can be given effect without the
- 2 invalid provision or application, and to this end the provisions
- 3 of this Act are severable.
- 4 SECTION 7. This Act shall take effect upon approval.
