STATEMENT OF OBJECTIONS TO SENATE BILL NO. 2644

Honorable Members Twenty-Fourth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 2644, entitled "A Bill for an Act Relating to The State Historic Preservation Officer."

The purpose of this bill is to amend the qualifications of the State Historic Preservation Officer to meet the required standards established by the United States Secretary of the Interior. Specifically, this bill requires the person appointed by the Governor as the State Historic Preservation Officer be qualified in architecture, architectural history, archaeology, history, culture, or a closely related field.

This bill is objectionable because the United States
Department of the Interior does not require that the State
Historic Preservation Officer meet professional qualification
standards.

Currently, the Chairperson of the Board of Land and Natural Resources serves as the State Historic Preservation Officer. The State Historic Preservation Division of the Department of Land and Natural Resources is managed by an Administrator who is responsible for the daily operations of the division and who reports to the Chairperson of the Board of Land and Natural Resources. The Administrator's position is also

referred to as the Deputy State Historic Preservation Officer.

The fact that the Chairperson of the Board of Land and Natural Resources serves as the State's Historic Preservation Officer has been a long-standing practice that has met with federal approval. Federal regulations specify that the State Historic Preservation Officer is responsible for maintaining a staff that meets the professional qualification requirements, but does not require the State Historic Preservation Officer to have those professional qualifications.

For the foregoing reasons, I am returning Senate Bill No. 2644 without my approval.

A BILL FOR AN ACT

RELATING TO THE STATE HISTORIC PRESERVATION OFFICER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the state historic 2 preservation officer is the administrator of the state historic 3 preservation program. The state historic preservation officer's 4 duties include reviewing nominations for the National Register 5 of Historic Places and maintaining data on historic places in Hawaii that have not yet been nominated for the National 6 7 Register of Historic Places. The state historic preservation 8 officer also serves as the State's consultant to federal 9 agencies during review regarding the federal Advisory Council on 10 Historic Preservation's regulations regarding the protection of 11 historic places. Federal agencies also consult with the 12 appropriate state historic preservation officer during their identification of historic properties and their assessment of 13 14 the effect of an undertaking on a historic property. 15 Due to the important role the state historic preservation 16 officer serves with regard to federal and state historic

preservation matters, the legislature in 1976 required the

- 1 Hawaii state historic preservation officer to be appointed on
- 2 the basis of professional competence and experience in the field
- 3 of historic preservation. The legislature finds that past and
- 4 present governors of the State of Hawaii have not appointed
- 5 Hawaii state historic preservation officers based on these
- 6 broadly worded qualifications and that basing this appointment
- 7 on nationally accepted and applied professional standards would
- 8 bring greater accountability and consistency to the appointment
- 9 of the Hawaii state historic preservation officer.
- 10 The purpose of this Act is to require that any person who
- 11 is appointed by the governor as a state historic preservation
- 12 officer, meets the required standards established by the United
- 13 States Secretary of the Interior.
- 14 SECTION 2. Section 6E-5, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "[+] \$6E-5[+] State historic preservation officer. (a)
- 17 The governor shall appoint a state historic preservation
- 18 officer, and may appoint the officer without regard to chapter
- 19 76, who shall be responsible for the comprehensive historic
- 20 preservation program and who shall be the state liaison officer
- 21 for the conduct of relations with the federal government and the

3	<u>(b)</u>	The state historic preservation officer shall [be
4	appointed	on the basis of professional competence and experience
5	in the fi	eld of historic preservation and]:
6	(1)	Be a qualified historic preservation professional in
7		architecture, architectural history, archaeology,
8		history, culture, or a closely related field, who
9		meets the professional qualification standards
10		established by the United States Secretary of the
11		Interior; and
12	(2)	Have professional experience with respect to historic
13		preservation in Hawaii.
14	<u>(c)</u>	The state historic preservation officer shall be
15	placed in	the department for the purposes of the state program.
16	<u>(d)</u>	Upon the appointment of a state historic preservation
17	officer by	the governor, the governor shall immediately advise
18	the presid	lent of the senate and the speaker of the house of
19	representatives of the identity of the person appointed and the	
20	person's qualifications to serve in that position."	
21	SECTION 3. Statutory material to be repealed is bracketed	

- 1 and stricken. New statutory material is underscored.
- 2 SECTION 4. This Act shall take effect upon its approval.
