A BILL FOR AN ACT

RELATING TO CAREGIVERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 204, Session Laws of Hawaii 2007, mandated
2	the joint legislative committee on family caregiving, created by
3	Act 285, Session Laws of Hawaii 2006, to explore, among other
4	things, alternative means of providing financial support for
5	family caregivers in Hawaii. Pursuant thereto, a Family
6	Caregiver Needs Assessment was prepared by a private contractor
7	for the joint legislative committee. The assessment stated, in
8	relevant part:
9	(1) It is estimated that nine per cent of caregivers in
10	the United States quit their jobs to provide care;
11	(2) Caregiving affected employment of one-quarter of
12	caregivers, mainly in reduced work hours or taking
13	leaves of absence;
14	(3) A state income tax credit for caregivers has the
15	greatest support among caregivers;
16	(4) Although caregivers are doing well overall in their
17	ability to provide care, there are certain impacts on

1 physical and mental health, finances, and employment, 2 for up to thirty per cent of all caregivers; and 3 (5) Caregivers tend to have lower income than expected, 4 especially given the high cost of living in Hawaii. 5 The purpose of this Act is to follow-up on the findings of 6 the Family Caregiver Needs Assessment by convening a working 7 group to explore various funding mechanisms that could potentially support caregivers. 8 9 SECTION 2. (a) There is established a working group, to 10 be under and report to the joint legislative committee on aging 11 in place, to explore various funding mechanisms that could potentially support caregivers, including income tax credits, 12 13 temporary disability insurance benefits, and unemployment 14 insurance benefits. The members of the working group shall include 15 16 representatives of the following entities to be selected by that 17 entity: 18 Department of taxation; (1)19 (2) Department of labor and industrial relations; Department of human services; 20 (3) Executive office on aging; 21 (4)National Federation of Independent Business;

- 1 (6) The Chamber of Commerce of Hawaii;
- 2 (7) University of Hawaii, department of economics;
- 3 (8) Society for Human Resource Management;
- 4 (9) International Longshore & Warehouse Union Local 142;
- 5 (10) Policy advisory board for elder affairs; and
- 6 (11) Hawaii Government Employees Association.
- 7 (c) The members of the working group shall designate a
- 8 chair from among its members.
- 9 (d) The working group shall serve without compensation and
- 10 shall receive no reimbursements for expenses. After making its
- 11 report to the joint legislative committee on aging in place
- 12 pursuant to subsection (a), the working group shall cease to
- 13 exist on June 30, 2009.
- (e) The department of labor and industrial relations shall
- 15 provide administrative support for the working group. The
- 16 legislative reference bureau shall provide drafting services for
- 17 the working group.
- (f) The joint legislative committee on aging in place
- 19 shall report findings and recommendations of the working group,
- 20 including any proposed legislation, to the legislature no later
- 21 than twenty days prior to the convening of the regular session
- 22 of 2009.

1 SECTION 3. This Act shall take effect upon its approval.
