of sound rationale, data, analyses, and input from state and
county agencies and the general public, and contain objectives

1 including the steady deterioration of public infrastructure; lack of affordable housing; continued reliance on a service-2 based economy; vulnerability of Hawaii in a volatile global 3 energy market; possible interruptions in travel and critical 4 5 food supplies; threats to fragile island ecosystems; and ever increasing numbers of residents and visitors. These issues all 6 7 raise questions about the long-term limits of growth in the 8 State and motivate the need to begin planning and action to assure Hawaii's future. 9

Addressing and solving issues critical to Hawaii's way of 10 11 life and natural resources requires coordinated community 12 efforts to produce comprehensive, long-range planning policies and actions. Within that context, the mission of the Hawaii 13 2050 sustainability task force and the objectives of the Hawaii 14 15 2050 sustainability plan are intended to revitalize the State's 16 long-term planning process to better guide the future 17 development of Hawaii.



§ -8 Sustainability indicators. The council shall
 develop, utilize, and analyze sustainability indicators, which
 shall serve as comprehensive measuring tools to determine the
 State's progress in the economic, cultural, and environmental
 impact sectors, and measure the State's efforts toward
 sustainability.

7 -9 Sustainability annual report cards. The council 5 8 shall research, develop, and publish report cards that chronicle 9 the State's current status on implementing and achieving the 10 objectives of the Hawaii 2050 sustainability plan. The report 11 card shall serve as an assessment for the approved 12 sustainability indicators for the State to analyze how the State is measuring up to the plan, and enable the State to make any 13 14 appropriate adjustments in its sustainability efforts.

15 § -10 Annual report. The council shall submit a
16 complete and detailed annual report of the council's activities
17 to the legislature. Beginning January 1, 2009, the annual
18 report shall be submitted no later than twenty days prior to the
19 convening of the regular session of each year.

20 § -11 Biennial audit. The books and records of the
21 council shall be subject to a biennial audit by an independent
22 auditor.

§ -12 Assistance by state and county agencies. Any
 state or county agency may render services upon request of the
 council.

4 -13 Court proceedings; preferences. Any action or S 5 proceeding to which the council, the State, or a county may be 6 party, in which any question arises as the validity of this chapter, shall be preferred over all other civil causes, except 7 8 election cases, without respect to position on the calendar. The same preference shall be given upon application of counsel 9 for the council in any action or proceeding questioning the 10 validity of this chapter in which the council has duly 11 12 intervened.

13 § -14 Construction of chapter. This chapter shall be
14 liberally construed to effect its purposes."

15 SECTION 5. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ or so 17 much thereof as may be necessary for fiscal year 2008-2009 for 18 the creation of a sustainability council to coordinate, 19 implement, measure, and evaluate the progress of the Hawaii 2050 20 sustainability plan and its related activities.

21 The sum appropriated shall be expended by the office of the 22 auditor for the purposes of this part.
