## A BILL FOR AN ACT

RELATING TO PARKING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to repeal the cap on
- 2 the allowable balance in the state parking revolving fund.
- 3 SECTION 2. Section 107-11, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "\$107-11 Parking; control by comptroller. (a) The
- 6 comptroller may assess and collect reasonable fees for parking
- 7 for all government officials and employees, install parking
- 8 meters, and restrict and otherwise control parking on all state
- 9 lands within the comptroller's jurisdiction.
- 10 (b) The comptroller may make such rules as may be found
- 11 necessary to carry out the objects and provisions of this
- 12 section relating to the control and restriction of parking on
- 13 all lands of the State which are within the comptroller's
- 14 jurisdiction. The rules shall be adopted as provided in chapter
- **15** 91.
- (c) Any person who violates any of the rules adopted by
- 17 the comptroller shall be fined not more than \$50 for each

- 1 part III of chapter 291, or any rule adopted thereunder, shall
- 2 be quilty of a traffic infraction under chapter 291D and shall
- 3 be fined or otherwise penalized in accordance with part III of
- 4 chapter 291.
- 5 (d) The comptroller is authorized to confer the powers of
- 6 police officers, including the power to serve and execute
- 7 warrants, arrest offenders, and serve notices and orders, to
- 8 employees of the department of accounting and general services
- 9 who are engaged as special officers to enforce this section.
- 10 (e) There is hereby created a fund to be known as the
- 11 "state parking revolving fund" which shall be used to carry out
- 12 the purposes of this section. Such amounts shall be expended by
- 13 the comptroller from the fund, as may be necessary, to defray
- 14 the cost of paving parking areas, the purchase and installation
- 15 of parking meters and the operation thereof, and of other
- 16 parking facilities on state land within the comptroller's
- 17 jurisdiction. The state parking revolving fund shall be used to
- 18 conform with the special fund depository requirements under
- 19 section 39-62 for all revenues and user taxes received as the
- 20 result of the issuance of any state parking facility undertaking
- 21 or loan program revenue bonds.

(f) All fees, charges, and other moneys collected pursuant 1 to this section, and all revenues and user taxes received 2 pursuant to section 39-62 as the result of the issuance of any 3 state parking facility undertaking or loan program revenue bonds 4 shall be deposited in the state parking revolving fund. 5 6 [(q) All moneys in excess of \$500,000 remaining on balance 7 in the state parking revolving fund on June 30 of each fiscal year shall lapse to the credit of the state general fund. On 8 9 July 1 of each year, the director of finance is authorized to transfer any excess funds in the state parking revolving fund to 10 the state general fund.]" 11 SECTION 3. SECTION 4. This Act shall take effect on July 1, 2008.
